Information sought:

The appellant filed an RTI application dated 01.05.2025 seeking information regarding PMKSY-2.0 at Jopu Nongo at Rilo.

Details of information required:-

(a) Please furnish the true / xerox copy of sanction order sanctioned against PMKSY-2.0 at Jopu Nongo at Rilo during the financial year 2024-2025.

(b) please furnish the name of Enterprise/Firm whose sanctioned amount has been transferred and xerox/true copy of PPA be provided.

(c) Since the project is beneficiary oriented, please furnish numbers and name of beneficiaries to whom payment has been made and amount paid against each beneficiary be provided.

(d) Please furnish xerox/true copy of newly appointed watershed committee members of the project if old approved watershed committee by the competent authority i.e. WCDC Daporijo has been rejected. Also furnish the reason for rejection.

(e) Furnish the xerox/true copy of the meeting minute of the village authority for formation of new watershed committee and also mentioned the name of person who have submitted the meeting minute.

Period: 2024-2025.

Relevant facts emerged during hearing:

Previous Hearings:

First : 24.10.2025
Second : 22.05.2026

Order of the 2nd hearing- *"The Commission observed that the representative of the PIO has delivered the information document to the appellant today in the Commission Court. The appellant sought time to examine the information furnished to him. The appellant is granted one week's time from the date of issue of this order. In case of any shortfall in the information furnished, the appellant is directed file a written submission to the PIO specifying the shortfall within the purview of the original RTI application in form A within one week and obtain written acknowledgement and furnish a copy of it to this commission within ten days from the date of issue of this order. The PIO shall furnish any additional specified information within one week upon receipt of such written submission by the appellant."*

The following were present.

Appellant : Present through VC. He states that the PIO has not provided any additional information even after receipt of his letter dated 26.05.2026 specifying shortfall information to the PIO.

Respondent PIO : Absent. APIO, Shri Temo Hane (EO) represented the PIO. He was not aware of anything about the ongoing appeal case.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records, hearing the parties observes that the PIO has not furnished additional/shortfall information at serial no (c) since the project is beneficiary oriented please furnish numbers and name of beneficiaries to whom payment has been made and amount paid against its each beneficiaries be provided, (d) Please furnish xerox /true copy of newly appointed water shed committee members of the project if old approved

watershed committee by the competent authority i.e. WDC, Daporijo has been rejected also furnish the reason for rejection and (e) furnish the xerox /true copy of the meeting minutes of the village authority for formation of new watershed committee and also mention the name of person who have submitted the meeting minutes, of his RTI application to the appellant.

The PIO is directed to furnish remaining shortfall information of his RTI application (c) *since the project is beneficiary oriented please furnish numbers and name of beneficiaries to whom payment has been made and amount paid against its each beneficiaries be provided,* (d) *Please furnish xerox /true copy of newly appointed watershed committee members of the project if old approved watershed committee by the competent authority i.e. WDC, Daporijo has been rejected also furnish the reason for rejection and (e) furnish the xerox /true copy of the meeting minutes of the village authority for formation of new watershed committee and also mention the name of person who have submitted the meeting minutes* to the appellant within 10 days from the date of issue of this order under intimation to this commission.

The appellant is directed to serve a copy of this order to the PIO, obtain acknowledgement and submit it to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
