ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tap Sajan, Down Polo Colony Naharlagun, Po/Ps Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by Shri Joram Lali, PIO-cum-EE, Information Technology Division Raj Bhawan, Power House, Department of Power, Itanagar, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 07/07/2025 regarding (a) Smart street lights of A.P. Legislative Assembly and State Museum Roads, (b) Additional Material requirement for smart street lighting of Itanagar town, (c) Smart street lighting on 9m octagonal G.I. pole with 135 wtt warm led white light colour luminaries along with the highway from Bharat patrol pump, Chimpu to ANYA Gate, Hollongi.
- 2). The 2nd hearing was held on 25th August 2026. Shri Joram Lali, PIO-cum-EE, Information Technology Division Raj Bhawan, Power House, Department of Power, Itanagar, Arunachal Pradesh, and the Appellant Shri Tap Sajan were present.
- 3). The PIO submitted that there was no such work done for which information had been sought at Sl.no. (a) & (b) of the Form A by the Appellant and that information sought at Sl.no. (c) had not been sanctioned yet. However, similar work as sought at Sl.no. (a) & (b) had been implemented, and those information were furnished to the Appellant as per direction of the Commission.
- 4). The Appellant informed the Commission that certain information was furnished by the PIO just before the hearing began but he needed time to scrutinize the same.
- 5). The Commission directed the Appellant to go through the information furnished by the PIO. In case any information was found lacking, the Appellant was advised to list out the non furnished information and submit to the PIO under intimation to the Commission within seven days from the date of issue of this order.

6). The Commission also directed the PIO to furnish complete information to the Appellant and if required facilitate the Appellant to have close interaction with the PIO and get clarification and complete information within fifteen days from the receipt of the list.

7). Further, the Appellant is also directed to collect information from the office of the PIO within fifteen days from the date of issue of this order and intimate his satisfaction or dissatisfaction to the Commission within twenty days from the date of issue of this order, failing which the case shall be disposed of.
