ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Ashok Sangbia for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PWD), Doimukh Division, Papum Pare District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 03.09.2025:

A.Details of information:

1. Certified copy of Category of all the work charged (W/C) staff serving under your division and sub-division
2. Certified Copy of Appointment letter of all the W/C staff serving under your Division and Sub-Division.
3. Certified Copy of Place of posting of all the W/C staffs serving under your Division and Sub-Division.
4. Certified copy of DPC Board member officers name & design of all the W/C staffs, along with trade test (TT) marks details of all the W/C staff recruited serving under your Division and Sub-Division.
5. Certified copy of approval from competent authority CE/SE of all the W/C Staff recruited/Advertised under your division & sub-division.
6. Certified Copy of present strength of W/C staff under serving your Division and Sub-Division.
7. Certified Copy of new strength of or against retirement or vacate of W/C staff serving under your division and sub-division.
8. Certified Copy of total sanction strength of W/C staff serving under your division and sub-division.
9. Certified copy of Recruitments rule (RR) of W/C staffs' approval from Administrative Reforms (AR) Department Govt. of (A.P).
10. Certified copy of attendance register of all the W/C Staffs serving under your division & sub division.
11. Certified Copy of Service identity card sign & seal of competent authority along with active contacts No. of all the W/C staff serving under your division and sub-division.
12. Certified copy of name & active contact No. along with service identity card, Superintending Engineer who appointed to the W/C Staff serving under your division & sub-division.
13. Certified copy of E-Data of all the W/C staff serving under your division and sub- division.
14. Certified copy of Joining Report/letter of all the W/C staff serving under your division and sub-division.

C.Periods for which information asked for: 2016 to till date

Brief facts emerging from the appeal:

Records in the appeal reveal that the appellant had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted him to file appeal before the First Appellate Authority (FAA), the Chief Engineer (PWD) Western Zone, Itanagar, Papum Pare District, Govt. of A.P. under section 19(1) of the RTI Act vide their Memo of Appeal dt. 07.10.2025. But having failed yet again to obtain the information, the appellant preferred second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dt. 10.11.2025.

This appeal was listed on 27.03.2026 wherein the appellant, Shri Ashok Sangbia was present through VC but the PIO did not appear. As such the hearing of this appeal had to be adjourned to today on 06.05.2026.

Today the appellant is absent who informed that he will not be able to attend the hearing due to pre-occupation in some urgent work. The PIO, Er. Shri Naresh Teli Comdir is present through VC.

Heard the PIO who submitted that most of the requested information/documents are ready for furnishing to the appellant. He, however, submitted that the requested documents at Sl. Nos. 4 to 9 are not held by his office as the o/o the Superintending Engineer is the recruiting/appointing authority of the W/C staff. As regards Service ID of the W/C staff, the PIO submitted that the ID Cards are issued by the District Administration and not by his office.

This Commission after hearing the PIO and on perusal of the documents/information requested by the appellant, which are found not exempted under the exemption provisions of section 8 of the RTI Act, 2005, directs the PIO to furnish the requested documents as are available in his custody and as regards those documents which are not held by his office, he shall furnish appropriate replies/reasons by way of an affidavit as required by section 7(8)(i) of the RTI Act r/w section-18(3)(c) and rule-5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005.

The PIO shall furnish the documents/ replies and/or affidavit to the appellant within 1(one) week from the date of receipt of this order and the appellant shall collect the same from the o/o the PIO and intimate the receipt thereof to this Commission within 1(one) week failing which this appeal shall stand closed without further notice.
