ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, PO/PS Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum-Executive Engineer, Govt. of A.P., Hydropower Dept. Hayuliang Division, Anjaw District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 06/10/2025 regarding total list of completed Plan & Non-Plan Works / projects sponsored by State fund / Central fund or both (such as SIDF/BE/RE/RIDF/SADA/ADA/MLA-LAD/MP-LAD/SPA/Article 275 (1)/PMJVK/PMDeVINE/NEC/NESIDS/ Non-BADP Maintenance work etc.) executed under the division, from the financial year 2019 to 2026.
- 2). The 1st hearing was held on 24th March' 2026. Er. Tage Tagia, PIO -cum-Executive Engineer, Govt. of A.P., Hydropower Dept. Hayuliang Division, Anjaw District, Arunachal Pradesh appeared before the Commission through online video conferencing. The Appellant Shri Tamchi Gungte was present in person.
- 3). In view of huge number of appeal cases by the Applicant against various departments, seeking similar information, the Commission sought an explanation from the Appellant.
- 4). The Appellant submitted that he was seeking only the list of the project implemented, not the details. He also informed that he had sought list of all the projects and some details to find out the lapses, and mismanagement in the implementation of projects and fund sanctioned.
- 5). The PIO submitted that on request of the Appellant, the information had been sent in his address through postal service on 11th March'2026.
- 6). The Appellant vide letter dated 08/04/2026 intimated the Commission that the information furnished by the PIO were not in sequence / serial wise, so it is difficult to go through and ascertain whether the document furnished by the PIO were correct or not. Also, the PIO had not furnished any forwarding letter, regarding the information furnished. Further, the Appellant appealed for a date of hearing.

7). The Commission in view of the appeal of the Appellant decided to fix a date of hearing. The PIO is directed to bring information in sequence as sought at Form-A dated 06/10/2025 with proper forwarding letter.

8) The next date of hearing is fixed on 2nd June'2026 (Tuesday) at 11.00am.

9).Therefore, the PIO -cum-Executive Engineer, Govt. of A.P., Hydropower Dept. Hayuliang Division, Anjaw District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

10). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
