An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC- 130/2026.

APPELLANT : Shri Tamchi Gungte near KV-II Chimpu.
RESPONDENT : The PIO, o/o the EE (PWD), Boleng Division, Siang Distt.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing by the PIO, o/o the EE (PWD), Boleng Division, Siang District of 30(thirty) point information on c/o "Plan & Non-plan Works/projects sponsored by State fund/Central fund or both (such as SIDF/RIDF/SADA/ADA/MLA-LAD/ MPLAD/ SPA/ Article 275(1) PMJKV erstwhile MsDP/ CRIF/ NEC/ NESIDS/ PMDeVine/ Non-BADP/ SASCI/ CMCSRPD /Maintenance works etc.) executed under the concern division" from the financial year 2016-17 to 2025-26 as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 25.09.2025.

This appeal was listed and heard on 08.07.2026, wherein the PIO was represented by Er. Shri Tuki Muang, ASW-cum-APIO while the appellant, Shri Tamchi Gungte was present in person with the documents since furnished by the o/o the PIO.

This Commission, after hearing the parties and noticing that the documents furnished by the PIO were not properly paged or flagged as complained by the appellant, directed the PIO or his APIO or any of his representative to be present in the Chamber of the Commissioner on 13th July, 2026 without fail to verify the correctness of the replies/information and explain the same to the appellant.

As directed, the APIO, Er. Shri Tuki Muang, ASW-cum-APIO, accompanied by one of the Junior Engineers of the Division and the appellant, Shri Tamchi Gungti are present.

This Commission notices from the statement of information furnished by the PIO in 2(two) instalments (the copy whereof was produced by the appellant), that the PIO had furnished the following information:

- 1) Documents pertaining to Financial year 2022- 2025 (1st phase);
- 2) Documents pertaining to Financial year 2019- 2022 (2nd phase).

The appellant submitted that the documents pertaining to FYs-2016-17 to 2018-19 and 2025-26 were not furnished. He also pleaded that since the documents furnished are not properly paged and indexed as per his queries, the documents be returned to the o/o the PIO and furnish to him in proper form and with flags and proper paging.

During the course of discussion, the APIO submitted that the documents/information pertaining to FYs 2016-17 to 2018-19 are in the o/o the Chief Engineer Central Zone-B, (PWD), Pasighat, East Siang District, the First Appellate Authority (FAA).

This Commission, however, observed that the APIO and the J.E were unable to do the sorting of the documents so far furnished vis-à-vis the appellant's queries. Therefore, this Commission deems it appropriate to direct the o/o to furnish the replies/documents with proper paging/flagging in a tabular form to the appellant, with intimation to this Commission, within 60 days from the date of receipt of this order and as such the documents so far furnished are returned to the PIO. The appellant shall, within 1(one) week of the receipt of the revised replies/documents, intimate this Commission for further consideration of the appeal failing which this appeal shall stand closed without further notice.
