Information sought:

The appellant has filed an RTI application dated 22.10.2025 seeking following information regarding compensation paid to beneficiaries of road from 0.00 km to 53.00 km under Dite-Dime to Migging road.

Details of information required: -

1. Furnish copy of name of the beneficiaries of land acquisition for 0.00 km to 53.00 km under Dite – Dime to migging road along with their disbursed amount reflecting against each beneficiaries planted name of species, structures and total land area.
2. Furnish copy of Govt. approved guild lines for land acquisition for 0.00 km to 53.00 km under Dite – Dime to Migging Road which was applied and taken into consideration while assessment and finalization of compensation bill amount disbursed to all beneficiaries of the said road.

3. Furnish copy of all Note – sheets of DLRSO and DC Boleng from beginning to approval of disbursement of compensation amount to beneficiaries reflecting the issue of road from 0.00 km to 53.00 km under Dite – Dime to Migging road.
4. Furnish copy of list of beneficiaries along with their planted species, structures and total land area surveyed and prepared by DFO, DHO and DAO of Boleng which was submitted to DLRSO and DC of Boleng for approval.
5. Furnish copy of payment register wherein beneficiaries gave their signature for withdrawal of their compensation amount.
6. Furnish copy of board of members who recommended the name of beneficiaries for land compensation amount.

The following were present.

Appellant : Shri Vijay Pertin present through VC. He states that information pertaining to serial 1, 5 and 6 not yet received.

Respondent PIO : Shri M Tamut, DLRSO present. He has brought the information document in the court.

On interjection, appellant Shri Vijay Pertin agreed to collect the information from the PIO by deputing his co-applicant Shri Kalom Perme within one week from the date of issue of this order.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the PIO has delayed in furnishing the complete information. Now he is directed to hand over the information document to the appellant within one week from the date of issue of this order and obtain acknowledgement of receipt and furnish a copy of it to this commission. The appellant shall file a status report of the information received to this commission within one week from the date of receipt the information document from the PIO.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
