ORDER

The 2nd hearing held on 21st July, 2026, related to the **APIC No-900/A/2025**. The Appellant Shri Lokam Namdu, present during the hearing and representative of the PIO Shri Bengia Sima, present during the hearing.

Heard the Appellant.

The Appellant stated that no information have been provided to him by the PIO till today.

Heard the representative of the PIO.

The representative of the PIO stated that the office of the PIO on receipt of the form 'A' of the Appellant on **13/10/2025** compile the information and wrote a letter to the Appellant on **13/11/2025** to deposit an amount of **Rs 102/- (Rupees one hundred two)** only as charges for the information, but the Appellant has not deposited the fees and it is the reason the information could not be handed over to the Appellant till today. I have brought the information in the court today and will hand over the same to the Appellant before the Commission.

After hearing both the parties the Commission hereby order;

- i) The Appellant to receive the information from the representative of the PIO and go through it to see whether the information are complete or not, as applied.
- ii) The Appellant to let the Commission, know whether the information as received are complete or not in the next hearing.
- iii) The PIO to be present in the next date of hearing without fail to ascertain from the Appellant that the information as provided by him, to the Appellant are complete or not.
- iv) The Appellant to be present in the next date of hearing without fail, **failing which the Commission will presume that the information provided by the PIO are complete and thereby the Commission will dispose of this appeal ex-parte.**
- v) Notice for next hearing need not be sent to both the parties as both the parties are present during hearing.

The Commission hereby orders;

The next date of hearing be fixed on 22nd Sept 2026 at 2:30 PM
