An Appeal Case U/S 19(3) of RTI Act, 2005. Vide Case No. APIC-1090/2023

ORDER

The 3rd hearing held on <u>25 November' 2025'</u> related to the <u>APIC No-1090/2023</u>. The Appellant Shri Nabam Sonu is present during the hearing before the Commission.

The PIO-cum-Director, Department of Environment & Forest and Climate Change, Govt. of Arunachal Pradesh is represented by Shri Punyo Tanya (Fr) during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that despite order from the court of this Commission to First Appellate Authority (FAA) to conduct hearing of the appeal on 09.10.2024, the First Appellate Authority (FAA) Department of Environment & Forest and Climate Change did not take up the hearing and thereafter the Appellant approached the Arunachal Pradesh Information Commission (APIC) for hearing this appeal and so the Arunachal Pradesh Information Commission (APIC) has started hearing this appeal again Vide- APIC No. 1090/2023, for the reason that no information has been provided to the Appellant till now.

Heard the representative of the PIO;

The representative of the PIO stated before the Commission that the information as sought by the Appellant have been provided to him but, the record of which I don't have today. I will convey it to the PIO and submit it in the court in the next date of hearing.

After hearing both the parties and going through the Form-A application of the Appellant the Commission hereby order as follows;

- i) The Appellant to be present in the next date of hearing in person or through online mode without fail, failing which this instant appeal will be heard and determined ex-parte.
- ii) The PIO to be present in the next date of hearing in person or through online mode without fail, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.

iii) Notice for the next date of hearing need not be issued to both the parties as they are present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 31st day of March' 2026 at 2:30 PM (Evening).
