An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC-405/2026.

APPELLANT : Shri MamuSono, Sood village Nlg.
RESPONDENT : The PIO, o/o the EE (PWD) Capital Division-B, Itanagar.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Mamu Sono for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD) Capital Division-B, Itanagar as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 17.02.2026.

A) Particular of information: c/o CC Pavement road from Ganga via Jullang to PapuNallah.

B) Details of information required:

1. Furnish the copies of MoU/MoA agreement.
2. Furnish the copies of total sanction amount order letter.
3. Furnish the copies of executed contractors/ firms name.
4. Furnish the copies of acceptance letter awarded to the contractor/firm.
5. Furnish the copies of financial, technical and final bidding documents.
6. Furnish the copies of works experience documents of the contractor / firm.
7. Furnish the copies of U/C submitted by the department.
8. Furnish the copies of monitoring report, money receipt and completion report.
9. Furnish the copies of name of the 3rdParty's monitoring agency along with guidelines for 3rdParty monitoring or implementation of above mentioned schemes.
10. Furnish the copies of news paper cutting published in any local or national dailies along with front page of the paper.
11. Furnish the copies of detail of GST Payment bills paid.
12. Furnish the copies of PA Holder and name of firm/company in details.
13. Furnish the copies of colour Videos and Photos Clips were taking before, during and after executed the works.
14. Furnish the copies of Geo Tagged (Before, during and after executed the works)
15. Furnish the copies of worker order and total numbers of tender participated list and total selected firms for awarded the above mentioned works.
16. Furnish the copies Concept Paper/DPR/Estimate and TS Copies in details.
17. Furnish the copies of MLA / Minister Note Sheet for winner of the tenders.
18. Furnish the copies of NIT and NIQ submission letters.
19. Furnish the copies cheques issued to contractors, firm, agency and company with cheque number in details.
20. Furnish the BOQ copies
21. Furnish the FF/RA/Bill Copies
22. Furnish the copies of EMD of the firms and copies of Bank Guarantees.
23. Furnish the copies MB and copies of bill vouchers books.
24. Furnish the copies of cheque counterfoils.

26. Furnish the copies of Comparative Charts/ statement charts.
 27. Furnish the copies contractor's class enlistment order copy/ trading licence details and contractor materials purchase invoice and copy of measurement book.
 28. Furnish the copies of details of payment/paid expenditure report supporting with monthly accounts upto 28/01/2026.
- C) Period for which information required: since from the execution work to till date.

Brief facts emerging from the appeal:

Records in the appeal reveal that the appellant had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted him to file appeal before the First Appellate Authority (FAA), the Superintending Engineer, (PWD) Capital Circle A.P, Itanagar, under section 19(1) of the RTI Act vide their Memo of Appeal dt. 25.03.2026.

Records also disclose that the First Appellate Authority conducted a hearing on 27.04.2026 where both the parties were present and on request of the APIO-cum-AE, Capital Sub Division, 5/B, PWD, Itanagar the FAA granted 03 (three) more weeks for final presentation of the documents. The speaking order of the FAA is reproduced hereunder:

"JUDGEMENT/ORDER

This is an appeal filed under sub-section 19 (3) of RTI Act, 2005. Brief fact of the case is that the appellant Shri. Mamu Sono had filed 02 RTI applications dated 17.02.2026 in Form-A to the PIO-cum-Executive Engineer, Capital Division-B, PWD, Itanagar seeking various information regarding "(1) C/o CC pavement road form Ganga via Jullang to Papu Nallah, (2) C/o Ring Road at Upper daath village near don Bosco college Jullang, Itanagar Papum Pare District", and other details as quoted in Form-A applications.

Appellant being not provided with the requisite information by the respondent PIO had filed the First appeals dated 25.03.2026 and accordingly the matter was heard before Er. Kipa Nakup, AE, Capital Circle, PWD, Itanagar, being the representative of FAA-cum-SE, Capital Circle, PWD, Itanagar on 27.04.2026 in the presence of Er. Joram. Takar, APIO-Cum-AE, Capital Sub-Division 5/B, PWD, Itanagar, being the representative of the respondent PIO and appellant Shri. Mamu Sono.

Heard the parties present.

In this hearing, the representative of the respondent PIO informed that due to the busy work schedule of the concerned departmental officials the requisite information could not be collected in time and sought 03 more weeks for the final presentation of the documents.

Hence, as per the agreement of the appellant with the said condition, it is hereby directed to the respondent PIO to provide the requisite information to the RTI appellant within 03 weeks from the date of issue of this judgment order.

In view of above facts and circumstances I find this appeal is fit to be disposed off and closed with liberty to the appellant to file appeal to the Appellate Authority if dissatisfied or aggrieved by the information provided through this hearing and, accordingly, this appeal stands disposed off and closed once for all.

However, the appellant preferred his second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dtd. 01.06.2026 on the ground that the PIO did not furnish the requested information.

This appeal is, accordingly, listed today on 28.08.2026 wherein the APIO, Er. Nabam Sony, A.E is present in person but the appellant, Shri Mamu Sono, is absent without any intimation/leave.

Heard the APIO, who submitted that the replies to the RTI application filed by the appellant had already been furnished to the appellant vide letter dt.25.02.2026 through Speed post on 26.03.26, a copy whereof along with the Post Office receipt, has been produced before the Commission during the course of hearing.

In the premises as above this appeal does not require any further intervention of this Commission and such this appeal is disposed of and closed as such and in terms of the stipulation contained in the summon notice that, in default of your appearance, on the day above-mentioned, the matter will be heard and determined, including closure of the appeal, in your absence.
