**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ashok Sangbia, Vill-Model Village Seppa, Po/Ps-Seppa, East kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-Chief Medical Superintending (TRIHMS), O/o Tomo Riba Institute of Health & Medical Science (TRIHMS), Naharlagun, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 18/07/2025 regarding Group C & D category serving under TRIHMS.
- 2). The 1<sup>st</sup> hearing was held on 3<sup>rd</sup> February' 2026. The PIO-cum-Chief Medical Superintending (TRIHMS), O/o Tomo Riba Institute of Health & Medical Science (TRIHMS), Naharlagun, Arunachal Pradesh appeared before the court through Video Conferencing. The Appellant Shri Ashok Sangbia was present in person.
- 3). The Appellant submitted that appointment of Group C & D category staff of TRIHMS were not conducted appropriately and therefore the information were sought to ascertain the veracity of the case. But the PIO did not furnish information as sought for in the Form-A dated 18/07/2025.
- 4). The PIO submitted that the information sought by the Appellant were under the jurisdiction of Directorate of Health, as all the appointments are done at the Directorate level. However, list of staff engaged under the TRIMHS had been furnished to the Appellant.
- 5). The Commission after hearing both the parties and going through the Form-A dated 18/07/2025 asked the Appellant to visit the office of the PIO, have discussion and collect information. The Commission directed the PIO to furnish available information to the Appellant or give justifiable reasons in writing in case they were unable to furnish the available information; and in case, the information were not available or held by office, the PIO must give justifiable reasons through an AFFIDAVIT. The directions of the Commission should be carried out by 20<sup>th</sup> February'2026 by both the parties.

6). The Appellant was directed to intimate the Commission in writing, his satisfaction or dissatisfaction after receipt of the information.

7). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant fails to intimate to the Commission within ten days from the expiry of above time given, the case would be disposed of.
