Information sought:

The appellant filed an RTI application dated 04.09.2025 seeking following information regarding Frontier Highway from Bille to Migging (confined to Siang District only)

Details of information required: (CTC of the following)

- Furnish the copy of Details Project Report (DPR).
- Furnish the total number of beneficiaries; total amount deposited with counterfoil along with Chainage number.
- Furnish the various types of land rate per square metre and forest components.
- Furnish the land rate and its types along with forest components of each beneficiary with chainage number.
- Furnish the copies of Gift deed if any with chainage number.
- Furnish the copy of GPS Map/ Alignment Map for final disbursement issued to each beneficiary.

- g. Furnish the total number of local dumping if any with agreement, geo-tag and chainage number.
 - h. Furnish the actual kilometres acquired for the said project.
 - i. Furnish the No Objection Certificate issued by the Forest Department.
- Period for which the information asked: 2024 to till date

Appellant : Absent. Adv. Mani Pabin represented the appellant. He submits that the information sought at serial number b) and e) are denied by the PIO citing exemption under Section 8(g) of the RTI Act. Is not correct. He further states that the PIO has conveyed to him over telephone this morning that further information document is ready for delivery.

Respondent PIO : Absent.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the representative of the appellant and perusal of the records, observes that FAA has heard the first appeal filed to him on 11.11.2025 and passed an order with a direction to the PIO to furnish the information as sought by the appellant within one month from the date of issue of the order. The Judgement order passed by the FAA – Deputy Commissioner, Siang District is hereby upheld. While implementing the order of the FAA with his letter no. SD/LM/RTI-01/2017-18(part file)/234 dated 18th Nov'2025, the PIO has denied the information under serial number b) and e) in RTI application Form-A citing exemption under Section 8(g) of RTI Act, 2005. The PIO has not argued about it in the hearing by the FAA.

The exemption from disclosure of information under Section 8(g) says: *the information, the disclosure of which would endanger the life or physical safety of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes.* The information sought by the appellant at serial number b) and e) do not fall under this category. The PIO is directed to comply the order passed by the FAA by providing complete information to the appellant within one week from the date of issue of this order under intimation to this commission. The appellant shall submit a status report on receipt of information to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
