**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ashok Sangbia, Vill-Model Village Seppa PO/PS Seppa, East Kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PWD), Bameng Division, Seppa, East Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/05/2025 regarding Work Charge (W/C) serving under the Bameng Division & Sub-Divisions.
- 2). **The 1<sup>st</sup> hearing was held on 25<sup>th</sup> November' 2025.** Shri Kongo Gyadi, PIO-cum-EE (PWD), Bameng Division, Seppa, East Kameng District, Arunachal Pradesh, and the Appellant Shri Ashok Sangbia were present.
- 3). The PIO submitted that since W/C staff are constantly transferred and posted according to need of their services, the exact strength under one division cannot be provided. Also, the W/C staffs are recruited by the SE (Coordination) and therefore, the Appellant should approach SE (Coord) for the information.
- 4). The Commission, directed the PIO to give the total strength of the W/C under his division for a particular year / period. Under section 6(3) of the RTI Act the information which were beyond jurisdiction of the PIO-cum-EE (PWD), Bameng Division, the PIO was directed to forward the RTI Application to the SE (Coord) for further furnishing of information to the Appellant. The PIO was also directed to intimate the same to the Appellant and the Commission within fourteen days from the date of issue of this order.
- 6). The Commission asked the Appellant to approach the PIO under SE (Coord) and collect information. After receipt of information the Appellant was directed to intimate his satisfaction or dissatisfaction by 24<sup>th</sup> December 2025.

5). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant fails to intimate to the Commission within ten days from the expiry of above date given, the case would be disposed of.
