Information sought:

The appellant has filed an RTI application dated 14.10.2025 seeking following information regarding APPSC Exam 2024 Marksheet & Answer sheet detail.

Details of information required:

- Essay paper.
- General Studies I, II, III & IV (Paper).
- Optional paper I & II.
- Marksheet of the Personality test.

The following were present.

Appellant

: Present. He has stated that the PIO has refused to furnish his (Appellant's) individual marksheet & answer sheet details saying that the information is available on APPSC official website.

On interjection the appellant states that he has not received written judgement order in time from the FAA.

Respondent PIO : Absent.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the appellant, observes that-

The appellant has filed second appeal to commission on 19.01.2026 on the ground that the PIO has failed to comply the verbal instruction during the hearing on 21st Nov'2025 by FAA to furnish the answer sheet within ten days.

The commission's notice of summon for hearing on 27th April 2026 at 10.30 am was issued vide no. APIC/A/2026/793 dated 24.3.2026.

Whereas, the notice of summon for hearing on 27th April 2026 was revised vide corrigendum memo no. DG(RTI)03/2024/29 dated 10.4.2026 by re-fixing the date of hearing on 24th April 2026 at 10.30 am (today's hearing).

Whereas, the PIO of APPSC reported to this commission on 27.4.2026 and stated that he has not received the corrigendum memo no DG(RTI)03/2024/29 dated 10.4.2026. He has produced a copy of 21.11.2025 hearing judgement order no. PSC/SECY-01/2024/1776 dated 24.11.2025 of FAA along with his forwarding and clarification letter no. PSC/RTI/AESE-01/2025/11 dated 6th April 2026 to the appellant wherein he states that the process of scanning of Answer Booklet is on-going. The answer booklet of all the candidates shall be made available through the OTR credentials of respective candidates once the process is completed.

The PIO of the office of the Arunachal Pradesh Public Service Commission (APPSC) is directed to confirm the definitive date on which the process of scanning of answer booklet is completed and disclosure of it through OTR credentials of respective candidates enabled, to this commission within one week from the date of issue of this order i.e. on or before 5.5.2026.
