An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC- 647/2025.

APPELLANT

: Shri Aso Dalbong, Nirjuli, Papum Pare Distt.

RESPONDENT

: The PIO, o/o the Additional Deputy Commissioner Upper Siang District, A.P.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Aso Dalbong for non-furnishing of below mentioned information by the o/o the Additional Deputy Commissioner, Upper Siang District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 17.04.2025:

(A) Details of information required:

- 1) Date of advertisement and notification on Newspaper;
- 2) Extension reason of the contractual interview 24.03.2025 to 26.03.2025;
- 3) PM SHRI KV TUTING contractual teaching staff list with name and date of appointment/joining, (KVS NORMS)

(B) Three PRT selected candidates details:

- i) D.EL.ED. certificate with marksheet;
- ii) CTET Paper-I Certificate of Three Selected candidate in PRT;
- iii) Total marked obtained by three candidates from three MEMBER. i.e Member I, Member II, Member III;
- iv) Member-I, Member-II and Member-III marked to be displayed. Why not disclosed the Member-III, Marked list? As interview panel was conduct by three Member;
- v) Why three PRT candidate obtained marked into ratio of 56.56.56. same marks and how rank are decide?
- vi) Biometric detail of three selected list and photograph of interview and pass photo.

Records in the appeal reveal that the appellants had requested the Additional Deputy Commissioner, Upper Siang District Govt. of Arunachal Pradesh as the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted him to file appeal before the Deputy Commissioner, Yingkiong, Upper Siang District, Govt. of A.P as the First Appellate Authority (FAA), under section 19(1) of the RTI Act vide his Memo of Appeal dt. 24.05.2025.

Records further disclose that the Principal, Kendra Vidyalaya, Tuting, vide his letter dtd nil, has furnished information as under:

	iv) Member-I, Member-II and member-III marked to be displayed. Why not disclosed the Member-III marked list ? As interview panel was conducted by three members. v) Why three PRT candidate obtained marked in ratio of 56.56.56 same marks and how rank are decided ?	The acting Principal In-charge at the time exercised his discretion and acted as per wish in this matter.
	vi) Biometric details of three selected list and photograph of interview and pass photo	The information sought is not covered under 2 (f) of RTI Act 2005 as the RTI Act is not a forum for answering questions or giving clarification. (Biometric facility not available at Vidyalaya level.)

The appellant, not satisfied with the replies furnished by the K.V, Tutting as above, filed his 2nd appeal before this Commission as the 2nd Appellate Authority under section 19(3) of the RTI Act vide Memo of Appeal dt.22.08.2025 which was registered in this Commission as APIC-647/2025 dt.22.08.2025.

Summons were, accordingly, issued for hearing the appeal today on 14.11.2025 wherein no one is present from the K.V, Tutting but one Shri Bhijoy Libang is present on behalf of the appellant, Shri Aso Dalbong.

This Commission, however, notices that the Public Authority in question, the Kendra Vidyalaya, Tutting, Arunachal Pradesh is a Central Public Authority and since the 2nd Appellate Authority for the central public authorities is the Central Information Commission, the appeal in question is beyond the jurisdiction of this Commission and in view thereof this Commission deems it appropriate to return the appeal to the appellant to file the same before the appropriate authority, the Central Information Commission.

This appeal is, therefore, not entertained in this Commission, and accordingly returned to the appellant.


