ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PWD), Mechuka Division, Shi Yomi District Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.10.2024:

<u>Particular of information:</u> C/o "Cement Concrete Pavement road in Mechuka Township in Shi Yomi District (A.P) during the financial year of 2023-24

- 1. The certified sanction order copy.
- The certified PRC (Permanent Residence Certificate) submitted by the tender participant issued by the Competent Authority regarding domicile status with the districts as per Rule 4 (ii) (b) of the Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules, 2015& 2020.
- 3. The certified LOC copy with respect to the subject mentioned above.
- 4. The certified copy of Utilization Certificate.
- 5. The certified copy of Notice Inviting Tender (NIT) With respect to the subject mentioned above.
- 6. The certified Progress Report of the projects in physical and Financial Section till date.
- 7. The certified copy of completion certificate of the project.
- 8. The certified copy of Newspaper in which NIT was published (At least 3 newspaper name (One National & 2 Local) along with date of publication of Newspaper, as per Govt. approved Order.
- 9. The certified Design and Scope of Work in the projects.
- 10. The certified copy of Work Specification of the projects.
- 11. The certified copy of the documents submitted by tender participant for Technical Bid.
- 12. The name of Firms who won the tender work with respect to the subject mentioned above.
- 13. The name of officers and their Designation at the time of monitoring work.
- 14. The certified copy of Contractor Registration, pass work Completion, Contractor Enlistment Update reports of tender participant and winning firm.

- 15. The certified copy of EMD and Security money deposited by all the tender participant.
- 16. The certified Integrity Pact submitted by the tender participant.
- 17. The certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have 2 (two) or more incomplete ongoing commitment (projects /contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dated 01.08.2018).
- 18. The certified documents submitted by tender participant and winning firm, i.e copy of completed three similar work each of value not less than 40% of the estimate cost or completed two similar work each of value not less than 60% of the estimate cost or completed one similar work of value not less than 80% of the estimated in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
- 19. The Certified copy of Acceptance letter for tender work by the Executing Agency to the tender winning firm.
- 20. The certified copy of work order given to the contractor by the Executing Department.
- 21. The Agreement copy made between the contractor and the Executive Agency for the projects mentioned above.

- 22. The photograph of worksite (Glossy paper) before starting of work and photograph (Glossy paper) after completion of work.
- 23. The Geo Coordinate information for the work mentioned above.
- 24. The certified Payment details of the project till date.
- 25. The certified Solvency certificate certified by the Bankers, submitted by all the tender participant.
- 26. The certified Credit facility from Bankers (10% of the tender value) submitted by the tender participant.
- 27. The certified Affidavit to invest cash upto (25% of tender value) submitted by the tender participant.

Facts emerging from the appeal:

Records in the appeal reveal that the appellant had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one moth which prompted him to file appeal before the First Appellate Authority (FAA), the CE (PWD), Central Zone – B, Pasighat, East Siang District, Govt. of A.P. under section 19(1) of the RTI Act vide his Memo of Appeal dt. 16.12.24.

Records also reveal that the FAA had attempted to conduct the hearing of the appeal for 3(three) times on 22.01.2025, 18.02.25 and 13.03.25 but the Appellant did not appear in any of the hearings. Therefore, the appeal was disposed of by the FAA as not being interested by the appellant.

Be that as it may, the 2nd appeal having been preferred by the appellant registered in this Commission the appeal is listed for hearing today on 04.07.2025 wherein the PIO, Er. Shri Onit Borang, E.E is present in person with the documents but the appellant, Shri Tamchi Gungte is absent who informed vide letter dt.04.07.2025 that due to some serious health issues he will not be able to attend the hearing.

This Commission heard the PIO who complained that the appellant neither visited his office to collect the requested information nor attended the 3 (three) hearings of the appeal he filed before the First Appellate Authority without waiting for the information/ documents from the PIO. In the absence of the appellant, this Commission could not find out the reasons as to his non-appearance in the hearing conducted by the FFA. This Commission, however, perused the documents brought in by the PIO and found that he has brought in most of the information but documents lacked proper paging and indexing. As such, the documents are returned to the PIO and directs him to furnish them to the appellant with proper indexing and paging before the date of next hearing with intimation to this department.
