**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengia Mama, Dariya Hill Colony near Donyi Polo Road, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-Block Development Officer, CD Block, Pipsorang, Kra Daadi District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 20/01/2025 regarding Construction of Wire Rope Suspension Bridge over Palam river at Vogba in between Tami and Hanai village under Pipsorang in Kra -Daadi District, Arunachal Pradesh.
- 2). The 1<sup>st</sup> hearing was held on 17<sup>th</sup> March' 2026. The PIO-cum-Block Development Officer, CD Block, Pipsorang, Kra Daadi District, Arunachal Pradesh was represented by Shri Taji Sora, APIO-cum-EORE. The Appellant Ms Bengia Mama was present.
- 3). The Commission had directed the Office of the Directorate of SJETA, Govt. of Arunachal Pradesh, Itanagar to clarify, whether the Certificate issued by the GPC is valid or not within fifteen days from the date of issue of the order. The PIO was also directed to pursue the matter with the Director (SJETA), Govt. of Arunachal Pradesh, Itanagar and submit a clarification report to the Commission within fifteen days from the date of issue of the order. Neither the Directorate of SJETA nor the PIO submitted the report.
- 4). Had the matter been clarified with justifiable reasons on the certification report, by the Directorate SJETA, the case could have been disposed of.
- 5). The Commission, giving reasonable opportunity, directs the PIO to submit the report as directed by 30<sup>th</sup> September 2026, failing which, section 20(1) of the RTI Act 2005 would be invoked against the PIO.

6). The Commission, to ensure action by the PIO, decided to fix a date of hearing.

7). **The next date of hearing is fixed on 13<sup>th</sup> October 2026 (Tuesday) at 11 AM.**

8). **Therefore,** The PIO-cum-Block Development Officer, CD Block, Pipsorang, Kra Daadi District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

9). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant is absent the case would be disposed of.
