ORDER

The 6th hearing held on **28th April' 2026'** related to the **APIC No-242/2024**. The Appellant Shri Pisa Tapam is present during the hearing before the Commission.

The PIO-cum-Executive Engineer, (EE), Shri Nani Tapa, RWD, Layang Yangte Division, Kurung Kumey District, Govt. of Arunachal Pradesh is present during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the PIO has not provided him any information till date.

Heard the PIO;

The PIO stated that out of the information applied against the 17 (seventeen) works by the Appellant, only one work i.e under Serial No. 16 of the Form-A of the Appellant i.e construction of road from Leyang to Majuriang (35 Km) Stage-II has been executed by the Layang Yangte Division and rest of the works have been executed by the Executive Engineer, Koloriang Division, and therefore, the information for all those works may be available with the Executive Engineer, RWD, Koloriang Division. I can only provide the information for the work executed in my division. The delay in providing the information to the Appellant is due to the fact, that I have taken the charge as EE last October' 2025 and in the mean time I was not aware of this appeal but, as I came to know of this appeal, I am present in the hearing today.

After hearing both the parties, the Commission hereby observes;

- i) Section 6(3) of RTI, Act, 2005 states that on application made to the PIO, if the information are not available with him, the PIO is mandated to transfer the application to the competent PIO who will have the information(s). In such case as in the instant case, the earlier PIO has not done his part of transferring the Form-A of the Appellant to the competent authority who can provide the information.

After the above observation the Commission hereby orders;

1. The PIO to transfer the Form-A of the Appellant to the PIO-cum-EE, RWD, Koloriang Division under whose jurisdiction almost all the works for which the Appellant has applied for the information have been executed.

2. The PIO to provide the information for the Serial No. 16 of the Form-A of the Appellant pertaining to Construction of Road from Leyang to Majuriang (35 Km) stage-II on or before the next date of hearing.
3. The PIO to be present in the next date of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.
4. The Appellant to be present in the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte.
5. Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 14th day of July' 2026 at 2:30 PM (Evening).


