Information sought:

The appellant has filed an RTI application dated 11.11.2025 seeking following information regarding documents of Satam Sonio (Nodal officer) SJETA Scheme Branch.

Details of information required in form A :

- ① Furnish of Advertisement copy.
- ② Furnish of Interview viva & Writing & Examination Mark Sheet
- ③ Furnish of Date of Appointment Letter & Date Joining & Record.
- ④ Furnish of Qualification of Education & Education Mark Sheet copy
- ⑤ Furnish of record of Promotion regulation copy
- ⑥ Furnish of his Salary money Transaction copy.

Detail required information incorporated in the first appeal:

- a) Furnish the details of Advertisement copy in which local dailies.
- b) Furnish the date of interview.
- c) Furnish the date of promotion records.
- d) Furnish the recommendation from Minister/MLA/Higher Officer for promotion.
- e) Furnish the date of joining report.
- f) Furnish the copy of appointment letter.
- g) Furnish the Education Qualification of Sartam Sonio with Marksheet copy.

The following were present.

Appellant : Present. He appeals for order to furnish information sought at serial f), and g) in the first appeal list as it involves larger public interest.

Respondent PIO : Agreed to provide all information as admissible under RTI Act.2005.

F A A : Absent.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the list of information sought in the RTI Application inf form-A and in the First Appeal varies. The hearing took place based on the reply furnished by the PIO on RTI query list in first appeal. The PIO denied information sought at serial number f): Furnish Copy of appointment letter and g) Furnish the education qualification of Sartam Sonio with marksheet citing the reason that they are personal information exempted under Section 8(1)(j).

The Section 8(1)(j) of RTI Act, 2005 reads "*Information which relates to interest, or which would cause an unwarranted invasion of the privacy of an individual shall not be disclose unless the central public information officer or the state public information officer or the appellate authority as the case may be is satisfied that the larger public interest justifies the disclosure of such information*". Here the appointment order and the requisite educational qualification for appointment to a govt. service is of larger public interest to be disclosed. The PIO is directed to furnish the information within one week from the date of issue of this order under intimation to this commission. The appellant is directed to file a status report to this commission within one week upon receipt of the information.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
