ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengai Mama, Dariya Hill Colony, near Donyi Polo Road, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/03/2025 regarding construction of Suspension Bridge over Kojen river in between Rigia to Duchok in Upper Subansiri District, Arunachal Pradesh.

2). **The 2nd hearing was held on 28th April' 2026 (Tuesday) at 1100 hrs.** Er. Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh was represented by Er. Taku Raji, APIO-cum-AE(RWD), Daporijo Division. The Appellant Ms Bengia Mama was present.

3). The APIO submitted that due prescheduled meeting the PIO was unable to attend the Court hearing on 17th March'2026. However, the APIO, informed that the information were kept ready to be furnished and that he would come to Itanagar in the next five days and furnish information to the Appellant.

4). The Commission directed the PIO to furnish information to the Appellant within one week from the date of issue of this order. In case the PIO wished to visit the Commission, he should intimate to the Commission a day prior, so that the Appellant also can be intimated.

5). In view of non-compliance of the order dated 17th March'2025, the PIO is hereby imposed a penalty of Rs. 5, 000/- (Rupees Five Thousand) only under section 20(1) of the RTI Act 2005 as a caution and advised not to repeat such omission of the Court's order. *The PIO is directed to deposit the said penalty amount in favour of the Registrar, Arunachal Pradesh Information Commission, Itanagar through Treasury Challan in the Head of Account "0070-Other Administrative Charge". The penalty amount has to be deposited before 20th May' 2026 and the proof of depositing the amount through treasury challan has to be submitted to the Commission, failing which additional action shall be initiated under Section 20(2) of the Act i.e. recommendation for disciplinary action.*

6). The next date of hearing would be decided on the basis of action taken by the PIO and intimation from the Appellant. In case the Appellant failed to intimate to the Commission within ten days from the expiry of above time given to the PIO, the case would be disposed of.
