ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Donik Roru, Jully II, 6th Mile, Near ADM office, Po/PS Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO – cum - EE(PHED & WS), Tali Division, Kra-Daadi District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 18/10/2025 regarding **Extension & Improvement of WS at Tali HQ.**
- 2). **The rescheduled 1st hearing was held on 21st July' 2026 (Tuesday) at 1100 hrs. Shri Joram Nagu, AE, representing the PIO- Cum- EE (PHED) & WS), Tali Division, Krad-Daadi District, Arunachal Pradesh was present. The Appellant Shri Donik Roru was absent.**
- 3). Shri Donik Roru, the Appellant submitted a letter No. Nil dated 25/05/2026 requesting the Commission to re-fix the 2nd July' 2026 hearing to any other day as he had some important work at his village. Whereas, the Commission had not fixed any hearing on 2nd July'2026 but had initially fixed a hearing on 2nd June' 2026 which was later postponed and re-scheduled to 21st July' 2026.
- 4). On 17th July' 2026 (Friday), whatsapp message was sent as a reminder to the Appellant informing him about date of hearing on 21st July'2026. His mobile however, was not functional.
- 5). The representative of the PIO intimated that the Appellant had sought 6 items of information, out of which, the PIO furnished one item of information to the Appellant, and that he had brought the balance information to be handed over to the Appellant. The copy of information so compiled was handed over to the Commission for record vide his letter No. EE/PHED/RTI/Corr-01/2022-23 Dated 20th July' 2026.
- 6) The Commission in view of the absence of the Appellant, decided to dispose of the case.
