ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, PO/PS Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- EE(PWD), Anini Division, Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 16/12/2025 regarding total list of Completed Plan & Non-Plan Works / projects sponsored by State fund / Central fund (such as SIDF/ BE/RE/ RIDF/SADA / ADA / MLA-LAD /SPA/ Article 275 (1)/ PMJVK/ CRIFK/ PMDeVINE/ NEC / NESIDS / Non-BADP /SASCI /FMBAP / CMSRPD/ Maintenance works etc, executed under the division : from the financial year 2023-24 to 2025-26.
- 2). The 1st hearing was held on 7th July' 2026 (Tuesday) at 1100 hrs. Shri Millo Tade, APIO-cum-Assistant Engineer (PWD), Anini-Division Dibang Valley District, A.P. and Shri Tamchi Gungte, the Appellant were present.
- 3).The Appellant was furnished with information during the hearing. the Appellant had requested the Commission to give him time to go through it.
- 4). The Commission had directed the Appellant to go through the document and intimate his satisfaction or dissatisfaction within two weeks from the date of issue of the order.
- 5). The Appellant vide letter dated 21/08/2026 intimated that the PIO had furnished incomplete information. In view of the intimation, the Commission decided to fix a fresh date of hearing.
- 6). **The next date of hearing is fixed on 29th September 2026 (Tuesday) at 11 AM.**
- 7).**Therefore,** the PIO -cum- EE(PWD), Anini Division, Dibang Valley District, Arunachal Pradesh, is hereby directed to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.
- 9). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.

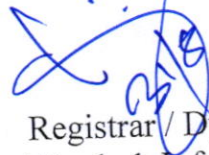
