ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tada for non-furnishing of below mentioned information by the PIO, o/o the E.E (PHE & WS), Yupia Division, Papum Pare as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 18.09.2025.

A. Particular of information: regarding P/W/S to various Schools and Anganwadi Centers of Balijan and Taraso Circle

B. Details of information required:

1. Furnish the certified copy of the guidelines for implementation of Budget Estimated(BE) Scheme from Government of Arunachal Pradesh.
 2. Furnish the certified copy of the Annexure-B-page no-3 and serial No-1 to serial No-21 all the contractors/Firms lists along with work order copies.
 3. Furnish the certified copy of the Annexure-B-page no-3 and serial No-1 to serial No-21 contractors/Firms documents namely (1) Contractor registration certificate (2) Trading license copy (3) GST Registration with latest return filling copy (4) Pan card copy (5) Aadhar card copy.
 4. Furnish the certified copy of the work completion report copy which was counter signed by school managing committees (SMC) of the all schools and Anganwadi centers supervisor along with documents must be duly put the seal & signature of thereof.
 5. Furnish the certified copy of the Name of the contractors and details of the firm to whom the works was awarded in the Annexure -B, page no-3 serials No-1 to serial No-21.
 6. Furnish the certified copy of the measurement books of every bill paid for the said works of the contractors/firms, in the Annexure -B, page no-3 serials No-1 to serial No-21.
 7. Furnish the certified copy of the first & final bills form of every bill paid for said works of all the contractor/firms.
 8. Furnish the certified copy of Geo tagging copy of the three stages: - Before the works commenced, after the works started and after the completion of the works.
 9. Furnish the certified copy of the non tendering works order issued against said works.
 10. Furnish the certified copy of the how many amount has been deduct for TDS/GST viz, CGST/SGST/Income tax or others taxable etc. details please.
 11. Furnish the certified copy of the cost justification of balance amount/fund.
 12. Furnish the certified copy of the work Status report along with audit report copy.
- C. Period for which information asked for: 2024-2025.**

Brief facts emerging from the appeal:

Records in the appeal reveal that the appellant had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month as prescribed under section-7(1) of the RTI Act which prompted him to file his 1st appeal before the First Appellate Authority (FAA), the Superintending Engineer, (PHE & WS), Itanagar Circle, Naharlagun under section 19(1) of the RTI Act vide Memo of Appeal dt. 23.09.2025. But having failed yet again to obtain the information, he filed his 2nd Appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dt. 19.02.2026.

This appeal was, accordingly, listed and heard on 10.07.2026, wherein the appellant, Shri Nabam Tadap was present in person but the PIO was absent without any intimation.

Heard the appellant, who, reiterating his demand for the requested information from the PIO, pleaded for an appropriate direction to him to furnish the information. The appellant also demanded that the PIO be penalised under section 20 of the RTI Act for non compliance of the RTI provisions and his failure to attend the hearing.

This Commission, upon perusal of the list of documents /information requested by the appellant, noticed that the same, except the Adhaar Card and PAN Card of the third parties, were not covered by any of the exemption provisions under section-8 (1) of the RTI Act. The PIO was, therefore, directed to furnish the sought for information/documents to the appellant in right earnest and report the compliance thereof to this Commission today on 14.08.2026.

Today on 14.08.2026 the appellant, Shri Nabam Tadap and the APIO, Er. Shri Nabam Atung, A.E are present in person.

This Commission heard the parties and during the course of hearing the APIO has produced the copy of PIO's letter dt.02.12.2025 by which the PIO had provided the information to the appellant. This Commission also retained the PIO's forwarding letter dt. 02.12.2025 along with the statement of replies / documents furnished to the appellant which are reproduced hereunder:

"D/Sir

The information asked vide your RTI application no.570 dated 26/09/25 in regards to the detail of documents seeking information on BE for Providing Water supply to various schools & Anganwadi centers against Tarasso & Balijan Circles under PHE & WS Division Yupia of Papum Pare Dist" the information provided is of 157 pages.

This Commission perused the statement of the information furnished by the PIO, and the observation of this Commission are indicated against each of the query as under:

1. Replies to Sl.No. (1) and (2) are found satisfactory.
2. As regards Sl.No.(3), the PIO shall furnish the Trading License and GST Registration of the Firms who executed the works/schemes but shall not furnish the Adhaar Card and PAN Card which are personal information of the 3rd parties.
3. Replies to Sl.No.(4) are satisfactory as the works are ongoing works.
4. Replies to Sl.No.(5) to (9) are satisfactory.
5. As regards Sl.No.(10), the PIO shall furnish the amount of TDS/GST deducted against the firms.
6. Replies to Sl.No.(11) is in order as the works is not a tendered work.
7. As regards Sl.No.(12), the PIO shall furnish the latest progress report/ status of the work.

The PIO shall furnish the above left out information / documents to the appellant within 1(one) week from the date of receipt of this order and the appellant shall, within 1(one) week thereafter, intimate the receipt of the documents to this Commission for further consideration of the appeal if so requires.
