ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, PO/PS Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- EE(PWD), Anini Division, Dibang Valley District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 16/12/2025 regarding **total list of Completed Plan & Non-Plan Works / projects sponsored by State fund / Central fund (such as SIDF/ BE/RE/ RIDF/SADA / ADA / MLA-LAD /SPA/ Article 275 (1)/ PMJVK/ CRIFK/ PMDeVINE/ NEC / NESIDS / Non-BADP /SASCI /FMBAP / CMSRPD/ Maintenance works etc, executed under the division : from the financial year 2023-24 to 2025-26.**
- 2). The 1st hearing was held on 7th July' 2026 (Tuesday) at 1100 hrs. Shri Millo Tade, Assistant Engineer (PWD), Anini-Division Dibang Valley District, A.P. and Shri Tamchi Gungte, the Appellant were present.
- 3). The Appellant informed that he had received a letter from the PIO asking him to deposit an amount of Rs. 3504/- only being the cost of the documents through online Treasury Challan. The Appellant informed the PIO that submission of Form- "A" was on 9th Dec' 2025, the waiting period had already crossed the 30 days time limit and hence he was exempted from paying the fees for the documents.
- 4). Accordingly, the PIO accepted his request and furnished the information to the address of the Appellant through postal services vide No. AD/RTI/E-69/2026-27/300-301 Dated Anini, the 15th June' 2026. But the Appellant replied that he had not yet received any information till date.
- 5). A copy of information was handed over to the Appellant on the direction of the Commission in the Court itself.
- 6). Having received the information copy the Appellant requested the Commission to give him time to go through it.
- 7). The Commission gave 2 weeks time to the Appellant to go through the documents and intimate his satisfaction or dissatisfaction.
- 8). Based on the input of the Appellant, the Commission will either fixed a fresh date of hearing or disposed of the case.

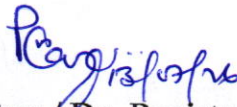
