ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Aman Bagang, s/o Tana Bagang, R/o Jayang Bagang, Po/Ps Chayang Tajo, East Kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DLRSO, Seppa, East Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 12/01/2026 regarding "Application and Representation submitted by JBFHCC (Jayang Bagnag Frontier Highway Compensation Committee) to DCS Office Seppa".

2). The 1st hearing was held on 1st September 2026. Shri Tashi Wanchuk Thundok, PIO-cum-DLRSO, Seppa, East Kameng District, Arunachal Pradesh appeared before the Commission through online video conferencing. The Appellant, Shri Aman Bagang was present in person.

3). The Appellant informed that the PIO had not furnished any information.

4). The PIO informed that he had joined as i/c DLRSO, Seppa, East Kameng on suspension of previous officer. The PIO, also informed that since present staff posted are new so it was difficult to trace out the documents. However, efforts were made and information have been kept ready to be furnished to the Appellant.

5). The Commission asked the Appellant to collect information from the office of the PIO and intimate his satisfaction or dissatisfaction to the Commission within fifteen days from the date of receipt of information from the PIO. The PIO is also directed to furnish information to the Appellant within seven days from the date of issue of this order.

7). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant failed to intimate to the Commission within fifteen days from the expiry of above time given, the case would be disposed of.

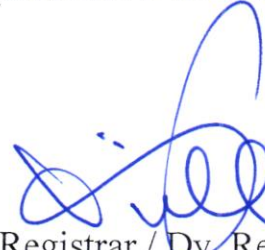
