





ARUNACHAL PRADESH INFORMATION COMMISSION ITANAGAR.

An Appeal Case U/S 19(3) of RTI Act, 2005 Case No. APIC-201/2025.

APPELLANT

: Shri Tamchi Gungte, near KV-II School Itanagar.

RESPONDENT

: The PIO, o/o the Block Development Officer, CD Block Bordumsa, Changlang District (A.P)

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 52 (fifty two) point information on "The total list project sanctioned under Pradhan Mantri Jan Vikas Karyakaram (PMJVK), erstwhile MsDP Scheme, Ministry of Minority Affairs Govt. of India" by the PIO, o/o the Block Development Officer, CD Block, Bordumsa, District Changlang, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 11.11.2024.

Hearing and decision:

This appeal is heard for the 3rd time today on 19.09.2025 the earlier 2(two) times being on 11.06.2025 and 03.09.2025.

On 11.06.2025, this Commission, after hearing the parties then and noticing that the information sought for by the appellant pertained to one funding head namely, 'Pradhan Mantri Jan Vikas Karyakaram (PMJVK)' (formerly, MsDP) and for one financial year i.e 2018-19, directed the PIO to furnish the requested documents/information to the appellant within one month from the date of receipt of order dt.13.06.2025 and it was made clear that if any of the requested documents was not being held by the o/o the PIO, then an affidavit to that effect with cogent reasons shall be furnished to the appellant as required under the appeal procedure rules.

The appellant had, however, complained vide his letter dt.11.07.2025 and subsequent letter dt. 31.07.2025 that the PIO failed to furnish the requested documents/information despite this Commission's order dt.13.06.2025 and as such pleaded for necessary action for non-compliance of the order and sought for hearing the appeal again.

This appeal was, therefore, heard again on 03.09.2025, wherein the appellant was present in person but the PIO Shri P.D Mishra (recently transferred and posted vice Shri Misa Gamlin, the earlier BDO) attended the hearing through VC.

The appellant reiterated his submission made in written complaint to this Commission earlier vide his letter dt. 31.07.2025. However, due to poor internet connectivity, the PIO could not be heard. Moreover, since the complaint of the appellant runs in to almost 12 pages (legal size), it was not possible to discuss and get clarification from the PIO on the entire complaints through such a poor internet connectivity.

Therefore, this Commission, with the consent of the PIO and the appellant, adjourned the hearing of this appeal to today on 19th September with direction to the PIO to be present in person or through his APIO or any other authorized officer with well versed knowledge of this appeal.

This appeal is, thus, heard today on 19.09.2025.

Today the appellant, Shri Tamchi Gungte is present while the PIO deputed Er. Shri Gandhi Tachang, JE who brought in some of the left out documents including the affidavit against those non-available documents, vide forwarding letter dt.15.09.2025...

The documents brought in by the J.E have been handed overt to the appellant who, however, complained that the affidavit furnished by the BDO do not bear the name of the deponent, the PIO which this Commission also noticed.

The PIO is directed to furnished a revised affidavit mentioning the name of the deponent, the PIO clearly therein within one week to the appellant with intimation to this Commission. The appellant is also directed to go through the documents so received by him today and intimate his satisfaction therewith within 2(two) weeks from the date of receipt of this order for further consideration of the appeal.
