ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Takar Jamoh for non furnishing of below mentioned information by the PIO-cum-EAC o/o the Dy. Commissioner, ICR Itanagar as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 20.05.2025.

Particulars of Information:

Details of Information required: RTI Queries pertaining to Municipal Electoral Roll under Ward No: 09 (Bank Tinali, Itanagar) (Now changed to Ward No. 09).

a. Does the Itanagar Municipal Electoral Registration Officer/ Authority have the Legal & Moral Responsibility to issue NOC/ CERTIFICATE/ Etc.(to be used for official use in new enrolment to other Municipality/ Panchayats under Arunachal Pradesh) to voters whose names have been deleted from the Itanagar Municipal Electoral Rolls ?, The answer if "NO" then provide a copy of such Orders (Gazette/ Administrative Orders).	Yes or No
b. Provide the reasons in WRITTEN as to why the concerned Municipality Electoral Registration is not willing to issue NOC/ CERTIFICATE/ Etc, against the deleted Electoral Roll under Ward No: 10 (previously ward no. 09) of Itanagar Municipality, to Shri Takar Jamoh whose previous voter ID bearing No. LSG0262261 & house No. E: 170-(copy enclosed)	Reply
c. Whether the Name of Shri. Takar Jamoh, with previous voter ID bearing No. LSG0262261 & house No. E-170 (copy enclosed) under ward no.10 (previously warn no, 09) is presently enrolled in the Itanagar Municipality Electoral Roll under Ward No: 10 (if YES provide the details & copy of the enrolment list). d. Provide the details on the Status of the voter ID bearing No. LSG0262261 with reference to the Municipality Enrolment record under ward no. 09.	Reply
e. Provide the copy of all the VALID Photo Voter Enrolment List/ Register under ward no: 09 (now ward no. 10) of Itanagar Municipal Electoral Roll for the Municipality Election years as under: *3. 2013 : Ward No.*09 (now Ward No. 10) 4. 2020 : Ward No. 10	Reply/List

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the Appellant, Shri Takar Jamoh had requested the PIO for the aforementioned information/documents but failed to obtain the same which prompted him to appeal before the Deputy Commissioner, Govt. of Arunachal Pradesh, ICR, Itanagar the First Appellate Authority (FAA) under Section 19 (1) of the RTI Act, 2005 vide Memo of Appeal Dated 20.06.2025.

However, the appellant having failed yet again to obtain the information preferred his second appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide memo of appeal dated 24.07.2025.

Hearing and decision:

This appeal is, accordingly, listed and heard today on 19.09.2025 wherein the PIO, Shri Khoda Lasa, A.C-cum-the Municipal Electoral Registration Officer (MERO), Itanagar, is present in person but the appellant, Shri Takar Jamoh is absent who informed that due to health issues he will not be able to attend the hearing.

Heard the PIO who submitted that the appellant, in his RTI application, basically wanted to know the competency of the Municipal Electoral Registration Officer (MERO) ICR, Itanagar to issue NOC and the actions taken by the MERO on the deletion of his names from the Itanagar Municipal Electoral Rolls. The PIO, producing the copy of relevant Rules i.e the Arunachal Pradesh Municipal Election Rules, 2011, submitted that the MERO, ICR, Itanagar is empowered to consider and dispose an appeal regarding the claims and objections

This Commission, upon hearing the PIO and on perusal of the provisions of rules-9,10,11 and 12 of the said Rules of 2011, notices that the MERO, ICR, Itanagar is empowered to consider and dispose off the claims and objections regarding the deletion of names in the Electoral Rolls of Itanagar Municipality.

In the premises as above, the PIO, the MERO, Itanagar is directed to furnish suitable replies (point-wise) in writing to the appellant enclosing therewith the extract of the relevant enabling provisions of the 2011 Rules with intimation to this Commission within 1(one) week from the date of receipt of this order.

This appeal is disposed of accordingly.
