The appellant filed an RTI application dated 13.12.2022 Seeking information regarding MLA Lad fund and DC united four MLAs Upper Subansiri District Daporijo (A.P)

Details of information required:

- Furnish accord administrative Approval & Sanctioned Order List copy under MLA Lad fund.
  - Furnish release of total fund allocation order copy list copy under MLA Lad fund against.
  - Furnish the beneficiary list copy under ML Lad fund against.
  - Furnish the work Geo Tag photograph by name of particulars place list copy MLA Lad fund against.
  - Furnish the bill payment voucher with signature of beneficiary's list copy.
  - Furnish the expenditure and UC list copy under MLA Lad fund.
- (II) DC united fund

- vii. Furnish the accord administrative approval & sanctioned order list copy.
- viii. Furnish accord administrative approval to release of total fund allocation order copy.
- ix. Furnish the work Geo Tag photograph by name of particular place a record list copy.
- x. Furnish the bill payment & bill voucher record list copy.
- xi. Furnish the expenditure & UC report list Copy.

Period from Which Information asked for: 2020 to 2023.

In eighth hearing ordered as: *"The commission observes that the appellant has not filed any written submission about the shortfall of information furnished to him by the PIO - DPO Daporijo in compliance of this commission order dated 05.09.2025. Now it is presumed that the information received by the appellant is to his satisfaction. The penalty imposed under section 20 (1) of RTI Act, 2005 and compensation to the appellant by Shri Tanam Kyali, PIO-ADC, Daporijo ordered by this commission court dated 15.12.2023 is not yet complied. He (Shri Tanam Kyali) is directed to comply this commission court order dated 15.12.2023 (copy enclosed) on or before 03.03.2025. Failure of which shall attract action under section 20(2) of RTI Act, 2005 to recommend for disciplinary action against you as PIO- ADC Daporijo under service rule applicable to you. Hearing adjourned. For next hearing notice shall be served to both Shri Tanam Kyali, ADC and Shri Tapak Rakmi, DPO Upper Subansiri District shall be served as respondent PIOs. Both should attend in person as it involves implementation of imposition of penalty by name under section 20 (1) of RTI Act, 2005."*

The following were present.

Appellants : Present. He has stated that he has received complete information from the PIO with Rs. 5000/- as compensation. But he has insisted for penalty which is not yet deposited by the PIO.

Respondent PIO : Absent.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the appellant and perusal of the records observes that the appellant has submitted a letter dated 04.10.2025 stating that the PIO is not complying with commission's order dated 17.02.2025.



Then PIO (Shri Tanam Kyali) is deliberately not complying with commission's orders as consecutively absenting the hearings as well as not depositing the penalty amount of Rs. 25,000/- which was imposed on 15.12.2023 by this commission.

Shri Tanam Kyali, SDO Daporijo, then PIO is directed to deposit the penalty of Rs. 25,000/- as ordered on 15.12.2023 on or before 29 December 2025 and submit a compliance report. Failure to do so shall liable for action against the then PIO Shri Tanam Kyali, SDO O/o the Deputy Commissioner under Section 20(2) under RTI Act, 2005.

Next date of hearing shall be fixed in due course of time.
