Information sought:

The appellant has filed an RTI application dated 29.12.2025 seeking following information regarding CAMPA fund for implementation of the items under "CA & NPV component of the state CAMPA AOP Vol-I & II during 2023-24, in respect of DFO, Kurung Kumey FD under Department of Environment Forests & Climate Change for amount not exceeding to Rs. 503.14095 Lakhs (Rupees Five Crore Three Lakh Fourteen Thousand Ninety-Five) & Rs. 359.76576 (Rupees Three Crore Fifty Lakhs Seventy Six Thousand Five hundred Seventy Six) for the year 2022-23 and during 2024-25 not exceeding Rs. 207.52872 (Rupees Two Crore Seven Lakh Fifty Two Thousand Eight hundred Seventy Two, under Koloriang.

Details of information Required: -

1. Furnish the work order/ technical sanction (TS) order copy with payments details like Xerox copy of Cheque leaf/demand draft/banker cheque/pay in slip for NEFT/RTGS slip/DBT against above mentioned work.
2. Furnish the certified copy of the notice inviting tender (NIT) along with two news paper channel and furnished the certified copy of the news Paper.

3. Furnish the Xerox copy of Enterprise trading license/letter pad of Enterprise/GST payment update copy /pan card/bill challan copy/Bank account number of Enterprise and full name & address and contact number /Aadhar card/PRC/ST of proprietor/Contractor.
4. Furnish the Deed of Agreement with the Department.
5. Furnish the details of the Firm and trading license along with the contact number of the owner.
6. Furnish the MB records/cashbook statement from the year 2022-2025.
7. Furnish the various name of deduction amount from contractor bill payment as percentage as per the Govt guidelines.
8. Furnish the certified coloring photocopy of all the work sites by concern RFO.
9. Furnish the coloring photocopy/video graph of work site which might be before starting of work/ ending of work with the mention exact location of work site.
10. Furnish the name of officers & officials with their signature/seal/stamp who have executed the work.
11. Furnish the full name & address/present address & mobile number and Xerox copy of Aadhar card/Pan card/ST/PRC.
12. Furnish the summary of LOC issued/granted from the office of the DFO.
13. Furnish the cross-section diagram.
14. Furnish the copy of award of work or agreement copy. b
15. Furnish the joint account of the DFO & RFO as per the billing.
16. Furnish the longitude and latitude of the accurate work site along with the Geo-tag report

The following were present.

Appellant : Absent. However, he has submitted a letter dated 26.8.2026 requesting the commission for adjournment of hearing date and to direct the PIO to furnish the information to him.

Respondent PIO : Absent.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records, observes that the FAA - Chief Conservator of Forest (Western Circle) Banderdewa has heard and disposed of the appeal case on 06.03.2026 with a direction to the PIO to furnish the required documents available with him to the appellant within 15 days from the date of issue of his order with intimation to his office. The FAA 's Order is upheld.

The PIO is absent in today's hearing without any intimation of the reason thereof, which is a violation of statutory duty of a public authority under the provisions of RTI Act, 2005.

Ex parte decision taken in the absence of PIO. The PIO is directed to furnish information sought to the appellant within 2 weeks from the date of issue this order under intimation to this commission. The appellant shall serve a copy of this order to the office of the PIO, obtain

acknowledgement and submit a copy of it to this commission. The PIO shall personally attend the next hearing or through his authorised representative.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
