ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Teli Ango, & Mr. Nagbia Kyokam, C/o Gauhati High Court Itanagar Permanent Bench, Yupia Naharlagun, PO/PS Naharlagun, District Papum Pare, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 18/11/2024 regarding PMGSY Road from Ompuli to Tamang Village, Toru Circle under Sagalee ST. Constituency District Papum Pare (A.P).
- 2). The 6th hearing was held on 28th April'2026. Shri Techii Totu Tara, the PIO-cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh was represented by Er. Kuma Welly, ASW, RWD Sagalee. The Appellant Adv. Teli Ango was present.
- 3). In the 6th hearing, the Commission had directed the PIO to compensate an amount of Rs. 5, 000/- (Rupees Five Thousand) only to the Appellant under section 19(8)(b) of the RTI Act and submit a copy of money receipt to the Commission. The Commission, considering the appeal of the APIO, reduced the penal amount from Rs. 25, 000/- to Rs. 5, 000/- (Rupees Five Thousand) only. The Commission thereby had directed Shri Techii Totu Tara, the PIO-cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division to deposit the amount in favour of the Registrar, Arunachal Pradesh Information Commission, Itanagar through Treasury Challan in the Head of Account "0070-Other Administrative Charge".
- 4). The PIO had compensated the Appellant and deposited the penalty amount as directed by the Commission. The proof had been submitted through Whatsapp on 29th April'2026.
- 5). The Commission had directed the Appellant to go through the information furnished by the PIO and intimate to the Commission his satisfaction or dissatisfaction within 15 (fifteen) days from the date of issue of the order dated 28th April'2026. The Appellant vide letter dated 5th May'2026 informed the Commission that the information furnished by the PIO were incomplete and appealed for continue of the hearing.

6). The Commission, directs the Appellant to submit list of incomplete information to the PIO and collect complete information before the next date of hearing.

7). **The next date of heaing is fixed on 14th July'2026 (Tuesday) at 11:00 AM.**

8). **Therefore**, the PIO-cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.

9). Take notice that in default of appearance on the day of hearing mentioned above, the appeal will be heard and determined ex-parte. If the PIO found absent, Section 20 of the RTI Act, 2005 shall be invoked on him/her and the case shall be disposed of if the Appellant found absent.
