ORDER

The 4th hearing held on **3rd February' 2026'** related to the **APIC No-48/2025**. The Appellant Shri John Tara Bakey is present during the hearing before the Commission.

The PIO-cum-Joint Director, Science & Technology, Shri Sang Ranpa Khochey, Itanagar, Papumpare District, Govt. of Arunachal Pradesh is present during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the PIO has furnished some of the information(s) which he received on 09.07.2024, and some of the information(s) are yet to be furnished to him.

Heard the PIO;

The PIO stated before the Commission that all the information(s) as sought by the Appellant in his Form-A have been furnished to the Appellant on 05.07.2024 which the Appellant received in person on 09.07.2024.

After hearing both the parties the Commission observes;

- i) The information as sought in his Form-A annexure-I of the Appellant, in Serial No. 13 has not yet been furnished to the Appellant.
- ii) The information(s) sought for furnishing the pay roll list of all employees under the office of the PIO-cum-Joint Director, Science & Technology, pertaining to the name and designation of employees receiving their salary from the office of the PIO is not yet furnished to the Appellant which has to be furnished by the PIO.

Under the above observations the Commission hereby orders;

- a) The PIO to furnish the pay roll list of all employees under his department without mentioning the salary amount on or before the next date of hearing without fail.
- b) The PIO to be present in the next date of hearing without fail, failing which necessary action will be initiated against him as per the provisions of RTI, Act, 2005

- c) The Appellant to be present in the next date of hearing without fail, failing which this instant appeal will be heard and determined ex-parte.
- d) Notice need not be served to both the parties for next date of hearing as both the parties are present in the court today.

The Commission hereby orders;

The next date of hearing be fixed on 28th day of April' 2026 at 2:30 PM (Evening).
