ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengia Mama, Dariya Hill Colony near Donyi Polo Road, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-Block Development Officer, CD Block, Koloriang, Kurung Kumey District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 20/01/2025 regarding Construction of Compound Wall around Upper Primary School Yumlam at Yumlam, in Kurung Kumey District, Arunachal Pradesh.
- 2). The 1st hearing was held on 17th March' 2026. Shri M.F. Bengia, PIO-cum-Block Development Officer, CD Block, Koloriang, Kurung Kumey District, Arunachal Pradesh and the Appellant Ms Bengia Mama were present.
- 3). The Commission had directed the PIO to furnish all the available information not exempted under exemption section of the RTI Act. For information exempted and information not available the PIO was asked to give justifiable reasons in writing to the Appellant under intimation to the Commission within fifteen days from the date of issue of th order 17th March'2026. The Appellant was also directed to collect information from the office of the PIO within fifteen days from the date of issue of the order and intimate her satisfaction or dissatisfaction to the Commission.
- 4). The Appellant vide letter dated 8th April'2026 appealed for continuation of hearing informing that the PIO had failed to comply with the direction of the Commission dated 17th March'2026.

- 5). The Commission in view of the appeal of the Appellant decided to fix a date of hearing.
- 6). **The next date of hearing is fixed on 26th May'2026 (Tuesday) at 1100hrs.**
- 7). Therefore, Shri M.F. Bengia, PIO-cum-Block Development Officer, CD Block, Koloriang, Kurung Kumey District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.
- 8). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
