ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengai Mama, Dariya Hill Colony, near Donyi Polo Road, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/03/2025 regarding construction of Suspension Bridge over Kojen river in between Rigia to Duchok in Upper Subansiri District, Arunachal Pradesh.
- 2). The 2nd hearing was held on 28th April' 2026 (Tuesday) at 1100 hrs. Er. Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh was represented by Er. Taku Raji, APIO-cum-AE(RWD), Daporijo Division. The Appellant Ms Bengia Mama was present.
- 3). The Commission had directed the PIO to furnish information to the Appellant within one week from the date of issue of the order dated 28th April'2026.
- 4). In view of non-compliance of the order dated 17th March'2025, the PIO was imposed a penalty of Rs. 5, 000/- (Rupees Five Thousand) only under section 20(1) of the RTI Act 2005 as a caution not to repeat such omission of the Court's order. *The PIO was directed to deposit the said penalty amount in favour of the Registrar, Arunachal Pradesh Information Commission, Itanagar through Treasury Challan in the Head of Account "0070-Other Administrative Charge". The penalty amount had to be deposited before 20th May' 2026 and the proof of depositing the amount through treasury challan had to be submitted to the Commission, but till date the PIO have not submitted the copy of Treasury Challan.*
- 5). The Appellant vide letter dated 18th May'2026 also informed that the PIO has not furnished information as directed by the Commission.

6). The Commission, giving reasonable opportunity to the PIO decided to schedule a hearing.

7). **The next date of hearing is fixed on 14th July'2026 (Tuesday) at 11.00 AM.**

8).Therefore, Er. Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.

9). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and disciplinary action under section 20(2) of the RTI Act shall be invoked against the PIO. In case the Appellant remains absent the case would be disposed of.
