Information sought:

The appellant has filed an RTI application dated 7.12.2025 seeking following information regarding appointment of RO, Nodal Officer, TO, LDC, UDC, Computer Operator, Peon, Assistant Accountant, Contractual Computer and Computer operator under Director, SJE & TA, Itanagar.

Details of information required: -

- 1) Furnish the advertisement copy of each candidate of every year.
- 2) Furnish the date of interview with viva-voice of each candidate of every year.
- 3) Furnish the marksheet of each candidate.
- 4) Furnish the educational qualification of each candidate.
- 5) Furnish the date of appointment letter of each candidate in every year.

- 6) Furnish the date of joining of each candidate in every year.
 - 7) Furnish the system of promotion/ regularization of each candidate, whether any Note sheet or any order copy was issued.
 - 8) Furnish the DPC record copy.
 - 9) Furnish all guidelines, proof of jobs selective /R. R Book.
- Period for which information is required: 2017 to 2025.

The following were present.

Appellant : Present. He states that there was no response from the PIO and FAA and information not furnished to him.

Respondent PIO : Present. He has brought the information document today to deliver it to the appellant.

F A A : Absent.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that this appeal case was remanded to the FAA – Director, SJE&TA, Itanagar on 7.4.2026 for hearing and adjudication within 3 weeks. He has submitted in writing dated 6.5.2026 that the hearing could not took place due to the meeting fixed by Ministry of Tribal Affairs, GoI with State govt. where the PIO had to attend the meeting. However, no summon notice of hearing is on record. Sufficient time period has elapsed during which the FAA should have heard the case. The FAA has not conducted the hearing during the stipulated time and thereafter also and thereby violates the statutory duty under RTI Act,2005.

The PIO has delivered today, the information document brought to the appellant. The appellant shall examine the information document and file a status report to this commission within one week from the date of issue of this order.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
