ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Licha Tabia & Shri Nabam Pekhi, Vill Dem. PO Deed, Ps Yachuli, Keyi Panor District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-BDO, CD Block Pistana, Keyi Panor District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/05/2025 regarding total sanctioned order copy for all the beneficiaries of Dem Panchayat under MGNREGA.

2). The 1st hearing was held on 9th September' 2025 as scheduled. Shri John Diru, PIO-cum-BDO, CD Block Pistana, Keyi Panor District, Arunachal Pradesh and the Appellant Shri Nabam Pekhi were present.

3). The Appellant submitted that the PIO had not furnished any information as sought for in the Form-A dated 08/05/2025.

4). The PIO informed the Commission that he had received the application of the Appellant a few days back but did not receive any summon or letter from the FAA on the basis of first appeal filed by the Appellant. Also, informed that since the information sought were of basic nature, these were available in the office. However, the PIO informed that sanction orders does not exist under MGNREGA.

5). The Commission directed the PIO to furnish all the available information within fifteen days from the date of issue of this order. In case information are not available, justifiable reasons in writing should be given through AFFIDAVIT. The Commission also asked the Appellant to visit office of the PIO and collect the information. Further, the Appellant was asked to intimate the Commission in writing, his satisfaction or dissatisfaction after receipt of information.

6). The next date would be decided on the basis of intimation from the Appellant. In case the Appellant fails to intimate to the Commission within ten days from the expiry of above time given to the PIO, the case would be disposed of.
