ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Gichik Tadik for non-furnishing of below mentioned information by the PIO, o/o the EE (WRD), Palin Division, Kra Daadi District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 31.12.2025.

A) Name of Scheme:

1. C/o JE Type-II Quarter at Tali in Kra Daadi District amounting Rs. 20.00 lakhs.
2. C/o EE & AE office for WR Division Palin amounting Rs. 40.00 lakhs
3. Strengthening and improvement of MIP/MIC under Tali Division in Kra Daadi District Arunachal Pradesh amounting Rs. 50.00 lakhs.
4. C/o Maintenance of MIP under Water Resources Tali Division in Kra Daadi District amounting Rs. 50.00 lakhs
5. C/o Maintenance of MIP under Water Resources at Rangha under Tali Division in Kra Daadi District amounting Rs. 50.00 lakhs
6. Strengthening and improvement of MIP/MIC at Rangha under Tali Division in Kra Daadi District Arunachal Pradesh amounting Rs. 50.00 lakhs.
7. C/o MIP at Kampok Rijo under Pillua village Pipsorang circle amounting Rs. 20.00 lakhs
8. C/o MIP at Piya stream to Chane Paddy field under Raba Karsang village amounting Rs. 20.00 lakhs
9. C/o MIPZ at Kollang (Pipsorang) amounting Rs. 20.00 lakhs
10. C/o Longte Gate at Damin amounting Rs. 20.00 lakhs
11. C/o MIP at Homi amounting Rs. 20.00 lakhs.
12. C/o MIC at Pami river stream to Pami Rianguio under Lota village, Tamuk amounting Rs. 40.00 lakhs

B) Details of Information:

1. Furnish details of sanction order copy from Govt., of A.P under RE-2024-25.
2. Furnish details sanction order copy from your district concern department and state government against RE for the year 2024-2025 of above mentioned schemes.
3. Furnish the Details Project Report of above mentioned schemes.
4. Furnish the copy of notification and NIT under RE-2024-2025 of above mentioned schemes/ Work order copy whom give the work firm.
5. Furnish the total number of firm/contractor participated in the said tender process and class of firm/contractors and type of tender.

6. Furnish the copy of declaration of tender bids result and name of the successful bidder along with rate quoted by successful bidder and other non responsive evolution.
 7. Furnish the name and designation of Tender Evolution Committee and copy of approval letter issued by the competent authority.
 8. Furnish the copy of work order and acceptance letter for processed to work to the successful bidders/firm/contractors and comparative statement with department rate of all technical qualified firm, BOQ of qualified firms and agreement letter, process work order letter and mobilization release amount.
 9. Furnish the copy of govt. guidelines under RE-2024-2025 order/notification and circular, if any for implementation of above mentioned work.
 10. Furnish the duration and stipulated period of above said project.
 11. Furnish the technical sanction order copy of above mentioned schemes.
 12. Furnish the technical bid and financial bid documents.
 13. Furnish site inspection report of each project starting to ending and monthly progress report.
 14. Furnish the bill copy and money receipt copy if released.
 15. Furnish the work executive EE/AE/JEs name of above mentioned schemes.
 16. Furnish Geo-tag & Photograph copy of each project from starting to ending.
 17. Furnish the Utilization Certificate.
 18. Furnish the NOC copy of concern village Le HGB, GBs of each project.
 19. Furnish the agreement copy with land owner should be made judicial stamp paper with seal and signature of judicial magistrate of above mentioned schemes.
 20. Furnish NOC from Forest, PHED & WS, WRD, RWD, Agri/Horti, PWD, Electrical etc. for non-duplicacy of the project.
 21. Details if any furnished along with cheque counterfoil and payment made for land compensation to any person, if so indicate the name of beneficiary.
 22. Furnish all the documents in CTC.
 23. Furnish the LOC copy time to time released.
- C) Period for which information asked for:- 2023-2025

Brief facts emerging from the appeal:

Records in the appeal reveal that the appellant had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted him to file appeal before the First Appellate Authority (FAA), the Chief Engineer (WRD) Western Zone, Itanagar under Section 19(1) of the RTI Act vide their Memo of Appeal dt. 02.02.2026. But having failed yet again to obtain the information, he preferred second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dt. 05.03.2026.

This appeal is, accordingly, listed today on 31.07.2026 wherein the appellant Shri Gichik Tadik is present but the PIO is absent.

This Commission, however, notices that there is no record of the FAA's conducting the hearing of the appeal.

The First Appellate Authority, under the RTI regime, is a quasi-judicial authority under section 19 (1) of the RTI Act, 2005 and as such he is required to hold hearing giving adequate opportunity to both the appellant and the respondent PIO and after applying his mind to the case / going into the aspect as to whether the information/documents requested by the appellants are disclosable or are exempted under the relevant provisions of section 8 or 9 of the RTI Act, pass a reasoned and speaking order.

Since, the FAA did not discharge his mandated duties as above, this appeal is a fit case to be remanded to the Chief Engineer (WRD), Govt. of A.P, Western Zone, Itanagar, the FAA for adjudication.

Accordingly, this appeal is remanded to the Chief Engineer (WRD), Western Zone, Itanagar, the FAA for adjudication and passing an appropriate order in speaking form within 1 (one) month from the date of receipt of this order. The PIO and the appellants are directed to appear in the hearing, when called for by the FAA.

This Commission also concludes that the appellant, if aggrieved by the decision of the FAA, may prefer his 2nd appeal before this Commission under section 19 (3) of the RTI Act within 90 (ninety) days from the date of the FAA's order for which no fees need be paid to this Commission.
