**ORDER**

1). The 3<sup>rd</sup> hearing was held on 14<sup>th</sup> July' 2026 (Tuesday) at 1100 hrs. Er. Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh was absent. The Appellant Ms Bengia Mama was present.

2). Besides failing to appear for the hearing, the PIO has failed to comply with the penalty imposed on him in the previous Court order.

3). The PIO has not even responded to the order of the Under Secretary (PWD), Government of Arunachal Pradesh Secretariat Rural Works Department Block No. 03, 3<sup>rd</sup> Floor Room No.08 Itanagar vide letter No. RWD-12/4/2025- RWD Dated Itanagar, the 15<sup>th</sup> June' 2026 endorsed to the Chief Engineer (WZ), Rural works Department, Arunachal Pradesh, Itanagar, directing the PIO-Cum- EE (RWD), Daporijo Division to appear before the RTI Court hearing fixed on 14<sup>th</sup> July' 2026 (Tuesday) at 1100 hrs in the chamber of HSCIC either in person or through Video Conferencing.

4). The absence of the PIO, without prior intimation and justifiable reason, is viewed seriously by the Court. Failure to comply with the court order is tantamount to contempt of the Court and sheer dereliction of duty as an officer.

5). The Commission hereby directs Shri Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District Arunachal Pradesh to **SHOW CAUSE as to why Penalty should not be imposed on him under section 20 (1) of the RTI Act, 2005**, failing which Arrest Warrant under Section 18(3) (a) of RTI Act, 2005 will be initiated to compel the presence of the PIO for the next hearing and, further, disciplinary action under Section 20(2) of RTI Act, 2005 would be invoked against him

6). The next date of hearing is fixed on 25<sup>th</sup> August'2026 (Tuesday) at 11.00 AM.

7).Therefore, Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.



8). In case the Appellant is found absent for the hearing the case would be disposed of.
