### **ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Khya Changrang for non-furnishing of below mentioned information by the PIO, o/o the Chief Engineer (RWD), Govt. of Arunachal Pradesh, Eastern Zone, Itanagar as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 28.08.2024.

**A. Particular of information:** M/s Zec Engineering & construction, NOCEAP (D&P)/PLG- 48/2008 – 09/1/62 dtd. 16/10/2008.

**B. Details of information required:**

1. Contractor Registration details including renewal status and company profile.
  2. Year wise list of all project undertaken by the contractor within the department.
  3. Copies of completion certificate, agreement and LOA Audit reports.
  4. Financial records including payment details.
  5. Records of legal or disciplinary action and any complaint reports.
- C. Period for which information is sought for:** 2010 to 2024.

### **Hearing & decision:**

The appeal is listed and heard today on 09.07.2025 for the 2<sup>nd</sup> time, the 1<sup>st</sup> time being on 23<sup>rd</sup> May, 2025 when the Appellant, Shri Khya Changrang was present but the PIO o/o the Chief Engineer, (RWD), Eastern Zone, Dist. Papum Pare, Itanagar was absent.

This Commission upon hearing the appellant and on perusal of the letter dt.07.05.2025 from the Chief Engineer (EZ), RWD, Itanagar as well as the letter dt. 27.10.2024 from the E.E, Anini Division, directed the E.E, Anini Division to furnish the left out information i.e. point number 3 and 4 to the appellant on or before 09.07.2025 i.e the next date of hearing.

Today on 09.07.2025 hearing, both the appellant Shri Khya Changrang and the PIO Er. Shri Kardo Rina, EE are present in person. As directed by this Commission in it's order passed on 23.05.2025, the PIO had brought in the left out documents and handed over to the appellant who, however, complained that the following documents are still remain to be provided to him and pleaded this Commission for direction to the PIO to provide:

1. Targeted date of completion of the project;
2. Drawing of the project;
3. Bill of quantity and
4. Notice of commencement of the project.

The PIO assured to provide the aforesaid remaining documents as soon as possible.

This Commission, upon hearing the parties, directs the PIO to furnish the left out documents to the appellant within 2(two) weeks from today and the appellant shall, within 1(one)week thereafter, intimate this Commission of the receipt of the documents failing which this appeal shall stand closed without further notice presuming that he had received the documents correct and is satisfied therewith.
