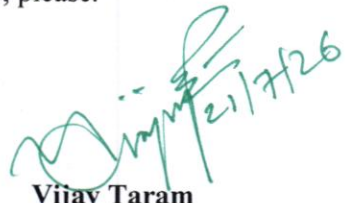

ORDER

The 2nd hearing held on 21st July' 2026 related to the APIC- No-856/A/2025. The Appellant Shri Chow Lajamang Mannow is present through online mode during the hearing before the Commission.

The PIO-cum-Executive Engineer, Shri Taluk Jeram, PWD, Khonsa Division, Tirap District, Govt. of Arunachal Pradesh, found absent consecutively for the second time without reporting the reason for his absence to the Commission despite hearing notice sent to him through WT Message from the Arunachal Pradesh Information Commission (APIC) on 16.02.2026 and another notice sent on 07.05.2026.

It is to be noted that the PIO has not bothered to report the reason for his absence despite of serving two notices for the hearing from this Commission.

Heard the Appellant;

The Appellant stated that he has went to the office of the PIO in person but could not meet the PIO as he was absent from the office.

The Appellant stated that he has not been provided with the information sought by the PIO till today.

After hearing the Appellant and recording the continuous absence of the PIO, the Commission order as given bellow;

- i) Issue **Bailable Warrant of Arrest** against the PIO-cum-Executive Engineer, PWD, Khonsa Division, Tirap District, for securing his attendance in the Third Hearing of this appeal, which is fixed on 22nd day of September' 2026 at 2:30 PM.
- ii) Issue order to the Officer-In-Charge, Khonsa Police Station, Tirap District, for executing the **Bailable Warrant of Arrest** and to return the same and produce the errant PIO on the next date of hearing of this appeal which is fixed on **22.09.2026, at 2:30 PM, without fail**, before this court.
- iii) The copy of this **Bailable Warrant of Arrest** be served to the Superintendent of Police, Tirap District for compliance.
- iv) The copy of this **Bailable Warrant of Arrest** be served to the Deputy Commissioner, Tirap District for information.
- v) The Appellant to be present in the next date of hearing without fail, failing which the Commission will hear and determine this appeal ex-parte.
- vi) Notice for the next date of hearing be served to both the parties.

The Commission hereby orders;

The next date of hearing be fixed on 22nd day of September' 2026 at 2:30 PM (Evening).

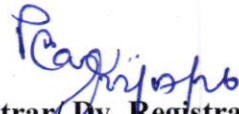
