The appellant filed an RTI application dated 09.10.2025 seeking following information regarding improvement of HT/LT lines including installation of 2 x 200 KVA/ 045 distribution of transformer at Sangdupota Administrative circle in Papum pare District.

- (3) Furnished the how many numbers of the HT and LT poles along with transformers are required at sangdupota administrative circle in Papum pare circle.

- (4) Furnished the how many villages are likely to covering aforementioned scheme and give their village's code numbers details.
  - (5) Furnished the how many numbers of the HT&LT Poles and Transformers are constructed or erected so far along with photograph/video graph copy.
  - (6) Please furnish/provide certify copy of the non-tendering work order issued against aforesaid works.
  - (7) Please furnish/provide certify copy of the official order inviting the firms/contractors for attending/participation of the tender process/called e-tender and also furnish copy of local/newspaper published aforesaid NIT.
  - (8) Please furnish/provide certify copy of the official order inviting the firms/contractors for attending/participation of the tender process/called e-tender and also furnish copy of local/newspaper published aforesaid NIT.
  - (9) Please furnish/provide certified copy of how many firms were qualified for technical bid and also how many firms has been recommended for price bid to set screening or scrutiny along with showing rate quoted by various firms
  - (10) Please furnish/provide certify copy of the Board proceeding for selection/acceptance bidders in connection with aforesaid contract work and other letter of correspondences.
  - (11) Please furnish/provide certify copy of the bill of quantity (BOQ) along with comparative statement of L,1 L,2 L,3 bidders.
  - (12)) Furnish/provide certified copy of the made correspondences to the successful bidder i.e.
    - (i) Formal letter of Acceptance(ii) Agreement made between contractor and Power department(iii) Issue of notice proceed with work(iv) Performance guarantee/Bank guarantee submitted by the contractors to Power department.
  - (13) Please furnish/provide certify copy of these listed firm's documents (1) M/s D.S Engineering (2) M/s Poma water park (3) M/s R.J Electrical i.e. (i) Contractor registration/Enlistment copy (ii) Trading license, (ii)ST Certificate (iv) PRC Certificate (v)GST registration with latest return filling copy Contractor (vi) Pan card Voter I.D (vii) Aadhar card (viii) ITR return filling copy (ix) EPF registration with Latest return filling copy.

  - (17) Please furnish/provide certify copy of the monitoring team report copy submitted against cited project along with copy of CD/Videography which was done by the monitoring team against the various components of work during the course of made to the contractor/agency.
  - (18) Furnished the utilization certificate along with audit report copy
  - (19) furnish the copy of Geo tag1&Geo tag 2, photocopy.
  - (20) furnish the certified copy of the work status report copy

**Appellant**

: Present. He states that the PIO has not complied the order of the First Appellate Authority irrespective of personal approach to the PIO. He demanded for appropriate action to the PIO under Section 20 of the RTI Act, 20025.

**Respondent PIO** : Absent.

**Decision:**

The Commission after adverting to the facts and circumstances of the case, hearing the appellant and perusal of the records, observes that FAA has disposed of the first appeal filed to him on 10.02.2026 with a direction to the PIO to furnish the remaining information as sought by the appellant by obtaining written permission of the third party within the 25 days from the date of issuance of their order. The absence of the PIO is observed as violation of statutory duty of a public authority in compliance of RTI Act.

The PIO is directed to comply the order of the First Appellate Authority – Chief Engineer (Power), Western Electrical Zone, Department of Power, Itanagar within two weeks from the date of receipt of this order. The appellant shall serve the copy of this order to the office of the PIO and obtain acknowledgement, and shall submit a copy of it to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.

Order pronounced in the Open Court of this Commission today this 10<sup>th</sup> day of July' 2026. Each copy of the Judgement / Order be furnished to the parties.

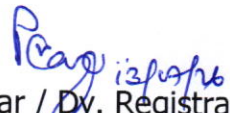
