ORDER

The 3rd hearing held on **16th day of July' 2026'** related to the **APIC No-735/A/2025**.
The Appellant Shri Godak Tama is present during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), RWD, Jamin Division, Kra-Daadi District, Govt. of Arunachal Pradesh is absent without reporting the reason for his absence to the Commission, wherein, his representative Shri Byabang Takar, Junior Engineer (JE)-cum-APIO was present in the court of the Commission in the last hearing held on 05.05.2026, and witness to the announcement of the next hearing held today.

Heard the Appellant;

The Appellant stated that the PIO has provided him in-complete information(s) on 05.05.2026, the information as applied in the Form-A under S/No. 2 date of news paper published for tender, S/No. 3 date of tender form issued, S/No. 4 date of tender opening, S/No. 7 Agency/Firm name which was awarded the work, S/No. 10 date of start of the work and completion date, have not been provided to him yet.

After hearing the Appellant the Commission cross checked the information furnished by the PIO, available with the Appellant and gone through the same information copy and found that the submission of the Appellant that the information as applied by him to the PIO in-complete.

After the above observation the Commission hereby order as follows;

- i) The PIO to provide the information as applied under S/Nos. 2, 3, 4, 7 & 10 of the Form-A of the Appellant on or before the next date of hearing without fail, failing which the Commission will impose penalty upon the PIO as provided under RTI, Act, 2005.
- ii) Send Summons to the PIO to be present in the next date of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.

- iii) The Appellant to be present in the next hearing without fail, failing which the Commission will presume that he has received complete information from the PIO, and thereby, the Commission will hear this appeal ex-parte and dispose this appeal.
- iv) Notice need not be sent to the Appellant as he is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 29th day of September' 2026 at 2:30 PM (Evening).
