Information sought:

The appellant filed an RTI application dated 03.12.2025 seeking information regarding RDSS (Revamped Distribution Sector Scheme) works under Tezu Electrical Circle.

Details of information required:

- Copies of Administrative Approval, Technical Sanction, and Detailed Project Report (DPR) of RDSS for Tezu Electrical Circle.
- Total sanctioned amount, component-wise (infrastructure, Metering, Loss Reduction, System Strengthening, etc.), division- wise.
- Name of the implementing agency, contractor(s), tendering authority. and agreement number.
- Furnish the certified copy of NIT published in newspapers against the issued RDSS projects.
- Furnish the certified copy of Bid evaluation report, work orders, Supply orders, executing agency, contract agreement and LoA (Letter of Award).

- (f) Furnish the list of all bidders who participated along with technical bid and financial bid details.
- (g) Copy of contract terms, including timeline for execution, penalty clauses, and payment terms.
- (h) Furnish the copy of comparative statement of all the <http://bidders.and> measurement book.
- (i) Furnish the CT copy of GPS Coordinate number & Geo Tagged details of before, in progress and after works.
- (j) Furnish the copies of GST paid clearance certificate, ITR filled of successful bidders and copy of E-Way Bill of the Firms as per the terms and conditions of the Govt. guidelines or NIT.
- (k) Furnish the CT copy of EMD, Contractor enlistment certificate, annual turnover certificate, bank solvency certificates, which had been submitted by the successful firms.
- (l) Furnish copy of work site verification report by the officers, their signature, designation & address.
- (m) Name the PMA (Project Monitoring Agency) for all the divisions along with date of joining and salary slip, division wise.
- (n) Furnish the copy of Treasury Challan Voucher and Cash book statement along with the amount withdrawn in the name of Executive Engineer/department.
- (o) Furnish the copies of Letter of credit (LOC) and their utilization/completion certificates.
- (p) Furnish the payments details paid to firms and department till date of furnishing the information.
- (q) Furnish all the Form-2 and Form-4.
- (r) Furnish the certified copies of inspection of the qualities of the materials of both the companies and Mercados (FMQI) Reports.
- (s) Furnish the details of transportation and payments for the materials sent to Mercados Energy Markets India Pvt. Ltd. for inspection of quality (like E-way bill, challan, vehicles, etc.).
- (t) Furnish the physical work progress report by both the department and contractor till date along with financial report (LOA supply and LOA erection).
- (u) Furnish the certified copies of stock register, bill of quantities, running accounts bill.
- (v) Furnish the distance between two poles in hills area and plain area, depth of poles to be buried along with concrete plaster details.
- (w) Furnish the name of Company certified for Smart meter.

The following were present.

Appellant

: Present through VC. He states that he is in receipt of the information document but there are some shortfalls and do not conform to information as sought in RTI application. So he is not satisfied with the information furnished.

Respondent PIO

: Present through VC. He states that some information sought are related to third party and personal information.

On interjection the appellant and the PIO could not specifically pin point out in clarity the information sought from serial no. a) to w), of which are third party information and which are personal information and the appellant has not sought clarification in writing about his dissatisfaction of information received from the PIO.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the FAA cum Chief Engineer (Power) Eastern Electrical Zone, Namsai has heard and disposed of the appeal case on 04.02.2026 with a direction to the PIO to furnish all the relevant documents to the appellant at free of cost within 90 days from the date of issue of his order. The appellant and the PIO could not specifically pin point out in clarity the information sought from serial no. a) to w), of which are third party information and which are personal information. The appellant has not sought clarification so far in writing about his dissatisfaction of information received from the PIO.

The appellant shall file a written submission stating specifically the short fall and dissatisfaction of information received by him to the PIO within one week from the date of issue of this order. The PIO shall respond and dispose of within 30 days upon receipt of such written submission from the appellant.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
