



## **ARUNACHAL PRADESH INFORMATION COMMISSION**

**An Appeal Case U/S 19(3) of RTI Act, 2005**

**Case No. APIC- 684/2025.**

**APPELLANT** : Shri Ha Tago, Shri Sartam Tallu & Tarh Nana Nirjuli.

**RESPONDENT** : The PIO, o/o the District Land Revenue & Settlement Officer (DLRSO) Kurung Kumey District (A.P)

### **ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from the appellants for non-furnishing of below mentioned information by the PIO, o/o the District Land Revenue & Settlement Officer (DLRSO) Kurung Kumey District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 27.06.2025:

**A) Particular of information:** Details information about the Land compensation and all other relevant document regarding the Frontier Highway stretch Huri-Taliha package-I & II under Kurung Kumey District.

**B) Details of information required:**

- a) A copy of Sanction order;
- b) A copy of Social impact report & Public notice of Land acquisition;
- c) A copy of Final bill list submitted by steering committee/department with Items wise/quantities rate of each beneficiary;
- d) A copy of list of steering committees and it members;
- e) A copy of funds provision allocates for survey and investigation with expenditure report includes Utility certificate and bill Voucher;
- f) A copy of total funds/amount against the beneficiary of Kurung Kumey district on ground of land compensation release from GOI;
- g) A copy of final ground survey report and total Kilometers of land areas of Frontier Highway package-I & II under Kurung Kumey District with Beneficiary chainage Numbers;
- h) A copy of Final Notification/declaration Report of the land acquired & beneficiaries list and amount of bill against each beneficiary;
- i) A copy of NOC for eligible beneficiaries from Gram Panchayat of concerned villages and it minutes or representation as per manual guideline;
- j) A copy of details of the beneficiary account where the compensation amount was disbursed or will disburse and a CTC copy of cheque vouchers and

k) A copies ofNOC from each land owners & agreement copy of land owners with department.

C) Period for Information asked for: 2024-2025

**Brief facts emerging from the appeal :**

Records emerging from the appeal disclose that the appellants, Shri Ha Tago, Shri Sartam Tallu & Tarh Nana requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted them to appeal before the Deputy Commissioner, Kurung Kumey District, Govt. of A.P, the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 28.07.2025. There is, however, no record of the FAA's conducting the hearing.

The appellants, it is seen, after the expiry of the prescribed period of one month for disposal of the appeal by the FAA, filed their 2<sup>nd</sup> appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide memo of Appeal dated 01-09-2025.

Accordingly, this appeal is listed today on 12<sup>th</sup> December, 2025 wherein one of the Appellants, namely, Shri Ha Tago is present in person any Shri Nguri John, Mandal, o/o the DLRSO, Kurung Kumey appeared through VC.

Heard the appellant who complained that the PIO did not furnish the requested information/documents as mandated by the RTI Act. The representative of the PIO, on the other hand, submitted that the o/o the PIO did not receive the RTI application filed by the appellant and that the copy of RTI application was received from the appellant only recently through Whatsapp. The representative also submitted that since the PIO is presently pre-occupied with the General Panchayat Elections, the documents /information shall be provided to the appellants after the completion of the election process.

This Commission perused the details of information/documents sought by the appellants and it is noticed that the documents as sought for are not exempted under the Act and therefore, the PIO is directed to furnish the same to the appellants within 15<sup>th</sup> January, 2026 with intimation to this Commission. The appellants are also directed to intimate this Commission of the receipt of the same on or before 19<sup>th</sup> January, 2026 for further consideration of the appeal failing which this appeal shall stand closed presuming that they have recieved the information/documents and are satisfied with the same.
