An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC-416/2026.

APPELLANT : Shri Taro Mosing, Jullang, Itanagar.
RESPONDENT : The PIO, o/o the AMDO, Palin, Kra Daadi District.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Taro Mosing for non-furnishing of below mentioned information by the PIO, o/o the Asstt. Mineral Development Officer (AMDO), Palin, Kra Daadi District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 25.03.2026.

A) Particular of information: regarding DMF(T)

B) Details of information required:

1. Furnish the bank details and Account No.
2. Furnish the bank statement with balance amount of DMF(T) from 1st January 2023 to till date.
3. Furnish the details of expenditure & utilization.
4. Furnish the details of the time to time audit report.
5. Furnish the copy of the Annual Report which is submitted to the State Govt.
6. Furnish the name & designation of Committee Board Member.
7. Furnish the copy of minutes of meetings and attendance for the DMG(T) fund utilize with proper signatures.
8. Furnish the name & designation of who operating trustee account of DFM(T)
9. Furnish the Govt. Notification quarry area.
10. Furnish all the certified true copy.

D) Period for which information asked: 2023 to till date.

Brief facts emerging from the appeal:

Records in the appeal reveal that the appellant Shri Taro Mosing had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted him to file appeal before the First Appellate Authority (FAA), the Deputy Commissioner, Kra Daadi District, Palin, Govt. of Arunachal Pradesh, under section 19(1) of the RTI Act vide their Memo of Appeal dt. 29.04.2026. But having failed yet again to obtain the information, he preferred second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dtd. 09.06.2026.

This appeal is, accordingly, listed today on 28.08.2026, wherein Shri Taro Mosing, the appellants is present in person while the PIO, Shri Byabang Gandhi appeared through VC.

Heard the parties.

The appellant, reiterating his demand for the requested information/documents, pleaded for an appropriate direction to the PIO to furnish the requested information. The PIO, however, submitted that he has despatched the information to the appellant yesterday on 27.08.2026. On instruction by this Commission, the PIO forwarded the copy of letter dt. 04.06.2026 through whatsapp by which he had furnished the replies to the queries of the appellant.

This Commission, on perusal of the reply furnished by the PIO noticed that against the queries at Sl. No.(1) and (2), the PIO had denied the information citing the exemption clauses under section-8(1)(d) and (j) of the RTI Act, 2005 which is not acceptable for the reasons that the appellant had asked for the bank statement of the public authority and not the personal information of any other third party.

The rest of the documents/information are also not covered by any of the exemption clauses. As such, the PIO is directed to furnish the information/documents in respect of the said two queries duly certified within 1(one) week from the date of receipt of this order as fairly agreed to by the PIO. The appellant shall, thereafter, within 1(one) week, report the receipt of the documents from the PIO failing which it is made clear that this appeal shall stand closed without further notice.
