**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Arjun Jebisow, Bhalukpong, West Kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PHE & WS), Govt. of A.P., Bomdila Division, West Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/10/2025 regarding Maintenance of mainline 200mm Dia pipeline and 150mm Dia pipe at Bhalukpong, BE provision LFY 2024-25.
- 2). The 1<sup>st</sup> hearing was held on 5<sup>th</sup> May' 2026. The PIO-cum-EE (PHE & WS), Govt. of A.P., Bomdila Division, West Kameng District, Arunachal Pradesh was represented by Er. Kipa Raju, AE (PHE & WS), Bomdila Division. The Appellant Shri Arjun Jebisow had appeared before the Court through video conferencing.
- 3). During the 1<sup>st</sup> hearing, the Commission had directed the PIO to furnish information for **sl.no. 4, 5, 6, 7 & 11 of the Form A dated 13/10/2025** as the Appellant had informed, those information were not furnished to him. The PIO was also directed that in case information were not available, justifiable reasons in written should be furnished to the Appellant under intimation to the Commission. The Commission also asked the Appellant to intimate his satisfaction or dissatisfaction after receipt of information.
- 4). The Appellant vide letter dated 26/05/2026 informed the Commission that the PIO had not furnished information and appealed for a date of hearing.
- 5). The Commission, giving reasonable opportunity to the PIO decided to fix a date of hearing.
- 6). **The next date of hearing is fixed on 14<sup>th</sup> July'2026 (Tuesday) at 11.00 AM.**
- 7). **Therefore, the PIO-cum-EE (PHE & WS), Govt. of A.P., Bomdila Division, West Kameng District, Arunachal Pradesh, is hereby summoned to appear before this Court in person or through Video Conferencing on the scheduled date and time without fail.**

8). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and penalty under section 20(1) of the RTI Act, 2005 shall be invoked. In case the Appellant remains absent the case would be disposed of.
