**ORDER/SUMMON**

The Appellant, Shri Bamang Pacho had filed 4(four) appeals under section 19(3) of the RTI Act for non-furnishing of information he had sought from the PIO vide his RTI applications as mentioned below by the PIO, o/o the E.E (PWD), Sangram Division, Kurung Kumey District:

The above 4(four) appeals were registered and heard in this Commission on different dates viz, APIC-366/25 dt. 07.11.2025, APIC-367/25 dt. 21.11.2025, APIC-368/25 dt.08.10.2025 and APIC-369/25 dt. 28.11.2025.

This Commission noticed that there is yet another appeal No.APIC-704/2025 filed by the appellant herein against the same respondent PIO, o/o the EE Sangram PWD Division wherein this Commission, after taking into account the submission of

the o/o the PIO, Sangram Division regarding the transfer and handing over of the documents relating to the schemes falling under the jurisdiction of the Koloriang Division, from the o/o EE, Sangram Division to o/o the EE, Koloriang Division, summoned the PIO o/o EE, Koloriang Division in the next hearing on 29<sup>th</sup> April 2026, along with the requested documents.

In the mean time another appeal No APIC-703/2025 filed by the appellant against the same respondent PIO was listed and heard on 27.05.26 and after hearing the parties, this Commission passed the following order:

*"During the course of hearing the PIO was reminded of this Commission's interim orders dt.21.01.2026 in 4(four) appeals namely, APIC-366/25, APIC-367/25, APIC-368/25 and APIC-369/25 and order dt.29.04.26 in APIC-704/25 which are pending final adjudication in this Commission against the instant respondent PIO and the PIO, Sangram PWD Division. The issues in those orders pertain to the question as to whose office, (whether that of PIO, Koloriang Division or that of the PIO, Sangram Division) will provide the information sought for by the appellant. The PIO, on pointed query, admitting fairly that the documents pertaining to the schemes falling under the jurisdiction of Koloriang have actually been transferred and handed over to the Koloriang PWD Division from the Sangram PWD Division on bifurcation of the Koloriang Division from the Sangram Division, confirmed that the PIO, o/o Koloriang Division shall furnish the requested documents / information, the records whereof are also currently under the custody of the CBI.*

*In view of the PIO's confirmation as above, this Commission concludes that the information/documents as sought for by the appellant in the aforesaid 5(five) appeals shall be provided by the o/o the PIO, Koloriang PWD Division and consequently, the PIO, o/o Sangram PWD Division shall, henceforth be no longer be summoned for hearing in the aforesaid 5(five) appeals. This Commission, thus, directs the PIO, Koloriang (PWD) Division to furnish the requested information / documents in all the 6(six) appeals, including the instant appeal, to the appellant as soon as the documents are received from the CBI."*

During the course of hearing the said appeal (APIC-703/2025), the PIO has categorically submitted that all the records/documents related to schemes against which information have been sought by the appellant and pending adjudication in the 6(six) appeals (supra), are currently under the custody of the CBI in view whereof this Commission concluded that no direction could be passed for furnishing those left out information which are reportedly, "untraceable" and are under the custody of CBI.

The PIO, Koloriang PWD Division was, however, directed, vide order dt. 29<sup>th</sup> May, 2026, to furnish those left out information/documents as sought for in all the 6(six) appeals namely, APIC-366/25, APIC-367/25, APIC-368/25 and APIC-369/25, APIC-703/25 and APIC-704/25 to the appellant as soon as the documents are received back from the CBI. The appellant was also directed to intimate this Commission within 1 (one) week of the receipt of the same from the PIO for further consideration of the appeals.

This Commission is now in receipt of letter dt.26.06.26 enclosing therewith a copy of EE, (PWD), Sangram Division letter dt.06.06.26 to the EE, (PWD), Koloriang Division returning the Measurement Book and other documents which were taken from the Koloriang Division for CBI enquiry. The extract of the appellant's letter and EE (PWD), Sangram Division are reproduced below:

a) Appellant's letter dt.26.06.26.

"R/sir/Madam,

With due humble request, this is a prayer for Re-Hearing of the above-mentioned subject Case Memo No. APIC.366/2025, 367/2025, 368/2025,369/2025,704/2025,703/2025. Therefor the instant appeal for information is available with the Koloriang Division, PWD, A.P, return by the Sangram division PWD, A.P after received from the CBI. Whereas the Koloriang division PWD is not furnishing the documents after receiving from the CBI, I hereby request you to call for immediate re-hearing of the instant appeal.
