ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Wangnon Wangnow, Forest Colony Longding, District Longding, Arunachal Pradesh, for non-furnishing of information by Shri R.W. Zimik, the PIO-cum-EE/ DPIU-II (PMGSY), Rural Works Department, Longding, Longding District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding Road from 1.54 km point of BRTF Konnu to PMGSY Road to Khonsa.
- 2). The 6th hearing was held on 4th August' 2026. Shri R.W. Zimik, the PIO-cum-EE/ DPIU-II (PMGSY), Rural Works Department, Longding, Longding District, Arunachal Pradesh was represented by Er. Jomson Jini, APIO-cum-JE. The Appellant Shri Wangnon Wangnow had appeared before the Court through video conferencing.
- 3). The Appellant informed the Commission that the construction deadline had finished last month but payment details of the project as sought for have not been furnished till date.
- 4). The APIO submitted that the project could not been completed as per the deadline fixed due to various obstacles in implementing the work. Therefore, a meeting was held and the deadline was extended to March'2027. It was unanimously decided and had been mentioned in minutes of meeting. The APIO assured to provide a copy of the minutes of meeting to the Commission.
- 5). The Commission had directed the APIO to provide the minutes of the meeting within two days from the date of hearing. However, inspite of repeated reminders, the APIO has not furnished the said minutes of the meeting. The Commission has, therefore, decided to fix a date of hearing. In the next date of hearing if the PIO fails to substantiate his claims with appropriate evidence, the Commission would recommend for disciplinary action against the PIO under section 20(1) of the RTI Act 2005.
- 6). The next date of hearing is fixed on 15th September'2026 (Tuesday) at 11 am.

7). **Therefore**, the **Shri R.W. Zimik**, the PIO-cum-EE/ DPIU-II (PMGSY), Rural Works Department, Longding, Longding District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.

8). Take notice that in case of default in appearing on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and **Arrest Warrant** under section 18(3)(a) of the RTI Act, 2005 shall be invoked against the PIO. In case the Appellant remains absent the case would be disposed of.
