**SECOND SHOW CAUSE NOTICE**



Arunachal Pradesh.

1. One Shri Techi Oum Tara, Shri Khoda John & Shri Likha Kojum has filed the Second Appeal against the PIO-cum-EE, PHE&WS Yachuli Division, Lower Subansiri District, before the Arunachal Pradesh Information Commission, Itanagar, on 17/05/2023 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-452/2023, wherein, alleging against the concerned PIO that he has failed to furnish information sought by him under 'Form-A', of his application dated 27.07.2023 relating to the matter as quoted in Form-A application.
2. The case is still ongoing in the Commissions' Court, the case was last heard on 20<sup>th</sup> day of Dec, 2023 you were served with Show Cause Notice vide no. APIC 452/2023/156 dated 20<sup>th</sup> Nov, 2023 & WT message vide no. APIC-452/2023/304 dated 30<sup>th</sup> Nov'2023 but you were found absent, nor did you send any representative on your behalf to appear before the Commission's court, whereas the appellant Shri Khoda John & Shri Likha Kojum were present. The case was heard ex-parte,
3. **The Commission** viewed seriously the gross violation of the RTI Act, 2005 and non-compliance with the directions of the court by the PIO. The Commission giving reasonable final opportunity hereby serve a Second Show Cause Notice as to why you should not be imposed with penalty under Section 20(1) of the RTI Act 2005 for violation of Sub Section (1) of the Section 7 of the RTI Act, 2005. Failing to appear in the next date of hearing in person the Commission shall invoke arrest warrant under section 18(3)(a) of the RTI Act, 2005 to compel your attendance before the Commission's court.
4. **Therefore**, you are once again directed to appear in person on 17<sup>th</sup> Jan, 2024 at 1030 hrs along with all the replies to the information sought by the appellant and the reason of your absence on 20<sup>th</sup> Dec, 2023 (previous hearing) before the Commission (APIC).
