SHOW CAUSE NOTICE

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

To

The PIO-Cum-Executive Engineer (RWD),
Laaying Yangte,
Kra-Daddi District, (A.P.)

WHEREAS, Shri Serpi Flago filed the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on **31.12.2024 U/S 19 (3) of RTI Act, 2005** vide Appeal No. **APIC-66/2025**, wherein, alleging that you failed to furnish information sought by the Appellant under Form-A of his application dated 14/10/2024 relating to the matter as quoted in Form-A application.

WHEREAS, you, being PIO-Cum-Executive Engineer (RWD), Laaying Yangte Division, Kra-Daddi District, Govt. of Arunachal Pradesh has refused to furnish the information sought under RTI Act, 2005 to the appellant **within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing penalty against you under the sub section (1) of section-20 of the Act.**

As per the case record on the 7th hearing dated 27/07/2026, last chance was given to the PIO to appear before the Commission in the next date of hearing i.e. on 03/08/2027, otherwise show because notice will be issued against him.

WHEREAS, date of hearing of the Appeals was intimated to you well in advance but you are found absent consecutively in **3(three) hearings on 204/05/2026, 27/07/2026 and 03/08/2026** before the Commission without any intimation to the Commission.

So, Show Cause Notice is issued to the PIO as to why not impose the Sub-Section-1 of the Section 20 against the PIO for the gross violation of the Sub-section-1 of the Section-7 of the RTI Act, 2005. The PIO-cum-EE(RWD), Laaying Yangte Division is directed to reply of the notice immediately and also directed to appear before the Commission in the next date

of hearing. If fails to comply the direction of the commission, Penalty shall be imposed against the PIO under Section 20 (1) of RTI Act, and thereafter disciplinary action u/sec 20 (2) of RTI Act will be recommended.

The Commission viewed seriously on the repeated absence of the PIO and showing reluctance attitude to appear in person before the Commission and knowingly & intentionally not complying with the order of the Commission in every hearing, inspite of the directions of the Commission and **failed to furnish the information within prescribed period.**

NOW THEREFORE, you are hereby directed to appear in person before the Commission (APIC), Itanagar for hearing and to furnish the **reply of Show-Cause Notice against you on or before 5th October, 2026 at 1030 hours as to why you should not be imposed a penalty as provided in Sub-Section(1) Section-20 of the RTI Act for violation of Sub Section (1) of the Section-7 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.**
