**LAST WARNING SHOW CAUSE NOTICE**

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

**WHEREAS,** Shri Kiosar Baki filed the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on **16/07/2025 U/S 19 (3) of RTI Act, 2005** vide Appeal No. APIC-583/A/2025, wherein, alleging that you failed to furnish information sought by the Appellant under Form-A of his application dated 07/05/2025 relating to the matter as quoted in Form-A application.

**WHEREAS,** you, being PIO-Cum-Executive Engineer (RWD), Daporijo Division, Upper Subansiri District, Govt. of Arunachal Pradesh has refused to furnish the information sought under RTI Act, 2005 to the appellant **within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing penalty against you under the sub section (1) of section-20 of the Act.**

As per the case record and order dated 15/07/2026, the APIO had stated before the commission that he would provide the information on that day of evening. Today the PIO found absent without any intimation to the Commission and no information has been provided to the appellant till date.

In this case already a Show Cause Notice was issued against the PIO on the 3<sup>rd</sup> hearing dated 20/05/2026 for non-compliance of the Commission's order.

So, **Last Warning Show Cause Notice** is issued to the PIO as to why not impose the Sub-Section-1 of the Section 20 against the PIO for the gross violation of the Sub-section-1 of the Section-7 of the RTI Act, 2005. The PIO-cum-EE(RWD), Daporijo Division is directed to reply of the notice immediately and also directed to appear before the Commission in the next

date of hearing. PIO is also directed to provide all the information sought as per Form 'A', if not exempted under the Provisions of RTI Act, 2005. If fails to comply the direction of the commission, necessary action shall be initiated against the PIO as per the RTI Act, 2005.

The Commission viewed seriously on the repeated absence of the PIO and showing reluctant attitude to appear in person before the Commission and knowingly & intentionally not complying with the order of the Commission in every hearing, inspite of the directions of the Commission and **failed to furnish the information within prescribed period.**

**NOW THEREFORE**, you are hereby directed to appear in person before the Commission (APIC), Itanagar for hearing and to furnish the **reply of Show-Cause Notice** against you on or before 12<sup>th</sup> October, 2026 at 1030 hours as to why you should not be imposed a penalty as provided in Sub-Section(1) Section-20 of the RTI Act for violation of Sub Section (1) of the Section-7 of the RTI Act, 2005 and failing which, matter will be heard and determined in your absence.

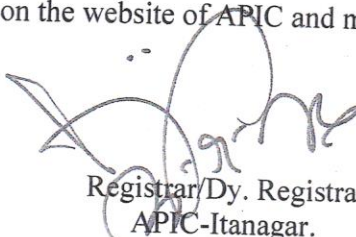
