JUDGEMENT / ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Marge Lombi on 10.02.2023 filed an RTI application in Form-A to the PIO, Office of the Deputy Commissioner, Likabali, Lower Siang District Govt. of Arunachal Pradesh, whereby, seeking information as quoted in Form-A application.

Appellant being not received information from the PIO filed the First Appeal before the First Appellate Authority on 05.04.2023.

The first appellate authority has not heard the appellant and PIO to dispose of the appeal. Appellant aggrieved of not being heard by FAA within time frame provided in the RTI Act, filed the Second Appeal before the Arunachal Pradesh information Commission on 30.08.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.854/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for 3rd hearing before the Commission Court today on 05.09.2024. Notice of hearing dated 14.08.2024 were served to PIO and the Appellant.

In this hearing of the appeal on 05.09.2024 the respondent PIO Shri Tajum Ronya EAC DC's office Likabali appeared. The appellant Shri Marge Lombi attended through online from Likabali.

Heard the parties present.

The appellant, while attending online, has requested the Commission to close and dispose of this appeal case as he has already received the required information. He states that the present PIO - Shri Tajum Ronya EAC has co-operated and promptly followed and provided the information to him in compliance of this Commission Court interim order dated 07.06.2024 unlike previous indifferent PIO – Shri Toni Mitkong, EAC and FAA – Shri Marto Riba, then Deputy Commissioner, Likabali. The Commission is in receipt of written submission to this effect dated 30.07.2024 from the appellant.

The PIO - Shri Tajum Ronya EAC states that all the certified copy of the information as sought by the appellant in his RTI application form-A has been provided to the appellant. He produced a copy of information document forwarding letter to the appellant dated 11th June 2024.

After hearing both the parties and in view of the above facts and circumstances I find this appeal is fit to be disposed of and closed. Accordingly, this appeal stands disposed of and closed once for all.
